



TOWN OF OAK GROVE, ARKANSAS
ORDINANCE NO. 76-2009

AN ORDINANCE ENUMERATING THE ALDERMANS POSITIONS ON THE CITY COUNCIL OF THE TOWN OF OAK GROVE, AND FURTHER REQUIRING THAT PERSONS SEEKING ELECTION TO THE POSITION OF COUNCILMAN DESIGNATE WHICH ENUMERATED POSITION THEY INTEND TO SEEK ELECTION TO.

WHEREAS, the City Council of Oak Grove, Arkansas, has determined that it needs to enumerate the Councilman's positions on the City Council in order to comply with the election laws of the State of Arkansas; and,

WHEREAS, the City Council of Oak Grove, Arkansas, intends to require that persons seeking election to the council indicate to which enumerated position on the Council they are seeking election;

NOW, THEREFORE, BE IT ORDAINED by the City Council of Oak Grove, Arkansas that from and after the passage of this Ordinance the following Councilman's positions shall be enumerated as follows:

1. The current position on the council held by Councilman Gary High shall be enumerated as Position No. 1.
2. The current position on the council held by Councilman Sam Jones shall be enumerated as Position No. 2.
3. The current position on the council held by Councilman Josh Peden shall be enumerated as Position No. 3.
4. The current position on the council held by Councilman Eugene Reynolds shall be enumerated as Position No. 4.
5. The current position on the council held by Councilman Janis Mc Kelvey shall be enumerated as Position No. 5.

BE IT FURTHER ENACTED that any person seeking election to one of these enumerated positions shall indicate upon filing with the Carroll County Election Commission to which enumerated Councilman's position they are seeking election, and said person shall also

comply with all other legal requirements under Arkansas law for seeking the position of alderman.

BE IT FURTHER ENACTED that this Ordinance being necessary for the preservation of the public peace, health, safety, and welfare of the inhabitants of Oak Grove, Arkansas, an emergency is hereby declared and this Ordinance shall be in full force and effect from and after its passage.
