

OAK GROVE TOWN COUNCIL MEETING MINUTES
November 3, 1987

The Oak Grove Town Council of the Town of Oak Grove, Arkansas, met at 7:00 p.m., Tuesday, November 3, 1987, at the Town Hall for its regular monthly meeting. The meeting was called to order by Mayor Jean Morgan, presiding officer.

On roll call the following members answered as their names were called: Aldermen Ira Allen, Alfred Atchley, Hugh Davis, Gary High, Mayor Jean Morgan, Recorder Delma Allen, and Treasurer Ruth Callen. Present 7, Absent 0. A quorum was declared.

The minutes of the meeting of October 6, 1987, were read and there being no corrections or alterations the minutes were approved as read. Motion was made by Alfred Atchley and seconded by Hugh Davis. All members voted in the affirmative.

The monthly bills were the first order of business. AML membership fee, Green Forest Lumber, Larimer Publication, Insurance on fire-station, NAEDD membership, office supplies, Attorney Epley's fee, Carroll Electric, and Tommy J. Davis's station. Hugh Davis made the motion to allocate money for the bills. Gary High seconded. The vote was unanimous to pay the monthly bills.

Next, Mayor Jean Morgan read the letter from the Arkansas Industrial Developmental Commission. The letter stated that notification of the rating on Oak Grove's application would be January 1, 1988.

The next order of business was the renewal of AD&D insurance for all the council members. Gary High moved to renew the insurance. Hugh Davis seconded. Aldermen A. Atchley, H. Davis, G. High, and I. Allen voted aye. None voted nay.

The next order of business was the discussion on the budget for 1988. Treasurer Ruth Callen reported that the appropriated amount will be drawn up and ready for inspection at the December meeting.

Another discussion topic was the annexation of property for two individuals who would like to have the city water connected to their property. The Mayor is to check on cost and legal steps for annexing property.

The next order of business was passing an Ordinance to assess millage for the Town of Oak Grove. Ordinance no. 21 assesses the same millage of 1.3 mills for real and 3.8 mills for personal property.

Treasurer Ruth Callen gave the financial report. The general fund has \$9,772.13. The street fund has \$6,993.44.

There being no further business to come before the council, Alderman Hugh Davis moved that the meeting be adjourned; Alderman Alfred Atchley seconded. All members voted aye. None voted nay.

Mayor Morgan presented Ordinance No. 21 to the council. After reviewing and discussing the ordinance to assess the millage, Alderman Atchley moved to place the Ordinance No. 21 on its first reading; Alderman Davis seconded. On roll call vote the following aldermen voted aye: Gary High, Ira Allen, Hugh Davis, and Alfred Atchley. None voted nay.

Mayor Morgan read Ordinance No. 21 in full.

Alderman Gary High moved to approve Ordinance No. 21 as read on its first reading; Alderman Ira Allen seconded. On roll call vote the following members present voted aye: Alfred Atchley, Ira Allen, Hugh Davis, and Gary High. None voted nay.

Alderman Alfred Atchley moved to suspend the rules and place Ordinance No. 21; AN ORDINANCE ASSESSING THE MILLAGE FOR THE TOWN OF OAK GROVE, ARKANSAS, IN THE COUNTY OF CARROLL COUNTY and placed it on the second reading by title only; Alderman Hugh Davis seconded. On roll call vote the following aldermen voted aye: Hugh Davis, Gary High, Alfred Atchley, and Ira Allen. None voted nay.

Mayor Morgan then read Ordinance 21 by title only.

Alderman Gary High moved to approve Ordinance No. 21 on its second reading by title only; Alderman Hugh Davis seconded. On a roll call vote the following aldermen voted aye: Ira Allen, Alfred Atchley, Gary High, and Hugh Davis. None voted nay.

Alderman Davis then moved to further suspend the rules and place Ordinance No. 21; AN ORDINANCE ASSESSING THE MILLAGE FOR THE TOWN OF OAK GROVE, ARKANSAS, IN THE COUNTY OF CARROLL COUNTY on its third and final reading by title only; Alderman Gary High seconded. On roll call vote the following aldermen voted aye: Alfred Atchley, Ira Allen, Gary High, and Hugh Davis. None voted nay.

Mayor Morgan then read Ordinance No. 21 by title only.

Alderman Ira Allen moved to approve Ordinance No. 21 on its third and final reading by title only; Alderman Gary High seconded. On roll call vote the following aldermen voted aye: Hugh Davis, Ira Allen, Alfred Atchley, Gary High. None voted nay.

Mayor Morgan then declared that Ordinance No. 21 was duly passed and approved .
