

OAK GROVE TOWN COUNCIL MEETING MINUTES

DATE: May 2, 1989

The Oak Grove Town Council of the town of Oak Grove, Arkansas met on May 2, 1989 at 7:00 p.m. in the town hall for its regular meeting. The meeting was called to order by Mayor Jean Morgan, presiding officer, and a quorum was established.

On roll call the following members answered as their names were called Alderman Aaron Curtis, Alderman Hugh Davis, Alderman Sam Jones, Alderman Gary High, Mayor Jean Morgan, Treasurer Ruth Callen, and Recorder Delma Allen. Alderman Larry Plumlee was not present. Present 7, absent 1.

The minutes for the April 4, 1989 meeting were read and there being no correction(s) or alteration(s), the minutes were approved as read. The motion to approve the minutes was made by Alderman Hugh Davis and seconded by Alderman Aaron Curtis. All members voted in the affirmative.

The next order of business is the presentation of the monthly bills: standing bills --- Allied Telephone, Carroll Electric, Maintenance on fire trucks, Maintenance on community grounds and ball park, propane bill ----NEW BILLS__ Green Forest Lumber, insurance on fire truck \$200. The motion to allocate money for payment was made by Alderman Aaron Curtis. Seconded by Alderman High__. The motion passed with 4 yeas and 0 nays.

The next order of business is the standing committees and reports by council members.

The first report ---Recorder Delma Allen reported that she had not heard from Mr. Atchley.

The second report by__ Alderman Davis reported that Lewis Eply agreed to take the job of legal council for the Town of Oak Grove.

The third report -- Alderman Aaron Curtis reported that he learned that the forestry had no idea when they would have one. It would probably cost \$10,000 to get one. Try to repair the one we have.

The fourth report ---Mayor Morgan reported that she had contacted Hutchins Construction in Cassville about doing some black topping. An approx cost of \$6,370 and would probably be June or after they finish Berryville's road work.

NEW BUSINESS TO COME BEFORE THE COUNCIL

Steve Allen reported on repair needed on the fire truck . A master cylinder and cups would cost approx. \$600 for parts and labor would be added expense. Alderman Aaron Curtis moved to get the fire truck repaired. Seconded by Hugh Davis. Vote was 4 yeas and no nays.

Another new item of business was the matching fund for the fire department. The fire chief, Ron High, pick out the equipment for the department and the city will match the \$500 plus an extra \$200 the help purchase the equipment. Motion by Alderman Aaron Curtis to allocate money for fire department. Seconded by Alderman Sam Jones. Vote 4 yeas and no nays.

The final item of business was the financial report given by Treasurer Ruth Callen. The general fund has \$7,822.41 and the street fund has \$13,511.79.

There being no other business before the council, Alderman High moved to adjourn this meeting. Seconded by Alderman Davis . All members voted in the affirmative and the meeting adjourned at 8:13 p.m.
