

OAK GROVE TOWN COUNCIL MEETING MINUTES  
DATE: July 2, 1990

---

The Oak Grove Town Council of the town of Oak Grove, Arkansas met on July 2, 1990 at 7:00 p.m. in the town hall for its regular meeting. The meeting was called to order by Mayor Jean Morgan, presiding officer, and a quorum was established.

On roll call the following members answered as their names were called - Alderman Aaron Curtis, Alderman Sam Jones, Alderman Gary High, Alderman Hugh Davis, Mayor Jean Morgan, Treasurer Ruth Callen, and Recorder Delma Allen. Present 7. Absent 1. Alderman Larry Plumlee.

The minutes for the meeting on June 5, 1990, were read. There being no corrections or alterations, Mayor Morgan ask for a vote. All members voted in the affirmative, and the minutes were approved as read.

The next item of business is the presentation of the monthly bills.

STANDING BILLS-- Allied Telephone, Carroll Electric Cooperative, Maintenance on fire trucks. Maintenance on community grounds and ball park, and Empire Gas Company of Blue Eye, Mo.

NEW BILLS-- No new bills presented. Motion to allocate money for payment of bills was made by Alderman Davis. Seconded by Alderman Curtis. The motion passed with 4 yeas and 0 nays.

The next item of business is the standing committees and reports by council members.

First report was given by Alderman Davis. He reported that he could not contact the people who did the paving. After a short discussion, he is to continue to try to contact them.

The second report by Alderman Jones. He reported that Ron High can not do the repair immediately. After a short discussion, Alderman Curtis, seconded by Alderman Davis, moved to have Alderman Jones contact R.D.High and have Mr. High do the jobs as soon as he can. All voted in the affirmative. Motion passed.

NEW BUSINESS TO COME BEFORE THE COUNCIL

First item of new business---is passing an ordinance which allows the Town to do business with the council members. The Ordinance #28 was placed for its reading. See attached excerpt.

The next item of new business was a report on the need of repair on the tractor. After a short discussion, Alderman Jones,

seconded by Alderman Gary High, moved to have Hugh Davis look at the tractor to see what it needs and to have Davis do the repairs if the tractor can be repaired. All voted in the affirmative.

The next item of new business was a discussion on buying an air conditioner for the conference room in the fire station. Motion by Alderman High, seconded by Alderman Davis, to have S.J. Jones purchase a unit and locate someone to install the air conditioning unit. All members voted aye. Motion passed.

The final item of business is the financial report was General fund has \$6,051.12 and the street fund has \$13,675.51

There being no other business to come before the council, Alderman - Davis - moved to adjourn the meeting. Seconded by Alderman - High-. All members voted in the affirmative and the meeting adjourned at 9:03 p.m.

The Town Council of the Town of Oak Grove, Arkansas, met in regular session at its regular meeting place in Oak Grove, Arkansas, at 7:00 o'clock p.m., on the 2 day of July, 1990. The following were present: Mayor Jean Morgan; Treasurer Ruth Callen; Town Recorder Delma Allen; and Aldermen Aaron Curtis, Sam Jones, Gary High, Hugh Davis. Absent Alderman Larry Plumlee.

The Mayor stated that consideration should be given by the council to the question of passing an appropriate ordinance to allow the Town of Oak Grove, Arkansas to do business with members of the council.

After discussion by the council, Alderman Hugh Davis introduced an Ordinance entitled:
