OAK GROVE TOWN COUNCIL MEETING DATE: JULY 7, 1992

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON JULY 7, 1992, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY RECORDER PAT CARLTON, IN THE AGBSENCE OF MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT - ALDERMAN SAM JONES, ALDERMAN GAY HIGH, ALDERMAN DEAN STANPHILL, ALDERWOMAN VICKI ALLEN, ALDERWOMAN PAT DAVIS, TREASURER RUTH CALLEN, RECORDER PAT CARLTON AND WATER SUPT. RON HIGH.

THE MINUTES WERE READ AND APPROVED FOR THE JUNE 2,1992 MEETING.

THE BILLS WERE PRESENTED, ALDERWOMAN VICKI ALLEN MADE MOTION TO ALLOCATE MONEY TO PAY THEM. ALDERWOMAN PAT DAVIS SECONDED THE MOTION AND ALL VOTED IN THE AFFIRMATIVE TO DO SO.

THE NEXT ORDER OF BUSINESS WAS OLD BUSINESS. ALDERMAN DEAN STANPHILL MADE A MOTION TO RESCEND THE PREVIOUS MOTION PERTAINING TO THE PARKING LOT AT THE COMMUNITY BUILDING. ALDERMAN SAM JONES SECONDED. ALL VOTED IN THE AFFIRMATIVE.

NEXT ORDER OF BUSINESS WAS RECONIGITION OF DELEGATION. JEANETTE PARTON WEAS PRESENT WITH THE QUESTION, CAN A PERSON ORDER ANY ONE OFF THE PREMISES OF THE COMMUNITY GROUNDS? A GROUP OF GIRLS WERE ASKED TO LEAVE AND NOT COME BACK. HER DAUGHTER WAS IN THE GROUP. SEEMS THERE WAS A COMMOTION AMONG A GROUP OF GIRLS AND BOYS, SHE SAID SOME WERE TOLD TO LEAVE WHILE OTHERS WERE NOT. CAN THEY BE ORDERED OFF FOR NO MORE OF A REASON THAN A GIRL SPAT? THIS WAS AT A SADDLE CLUB MEETING. SHE WAS TOLD SHE SHOULD HAVE TAKEN THE MATTER UP WITH BILLY STEWART AS HE IS THE PRESIDENT OF THE SADDLE CLUB. THIS ISN'T REALLY THE CITY COUNCILS BUSINESS. THE PARTY HAD NO RIGHT TO ORDER THEM OFF THE GROUNDS. THE PARTIES INVOLVED AND THE PRESIDENT OF THE SADDLE CLUB SHOULD GET TOGETHER AND STRAIGHTEN THIS MATTER OUT. IF THEY ARE ASKED TO LEAVE AGAIN CONTACT THE CITY COUNCIL AND WE WILL CONTACT THE PROPER AUTHORITIES.

NEW BUSINESS: ALDERMAN SAM JONES MADE A MOTION THAT VICKI ALLEN BE PAID \$175.00 TO HELP PAY EXPENSES FOR A SCHOOLING SHE IS GOING TO ATTEND IN LITTLE ROCK. VICKI IS ON CALL 24 HRS. A DAY AS A EMT FOR THE TOWN FIRE DEPARTMENT. THIS IS A SCHOOLING FOR SUCH. ALDERMAN DEAN STANPHILL SECONDED. ALL WERE IN FAVOR. STANDLY ANDRESKI HAS A PROBLEM WITH WATER RUN OFF. THE TIN HORN ISN'T DOING THE CORRECT DIVERTING, IT'S GOING THRU HIS YARD AND HOROLD SOOTERS FARM LAND. ALDERMAN GARY HIGH MADE A MOTION THAT WE ASK THE COUNTY JUDGE TO MEET WITH A COMMITTEE FROM THE CITY COUNCIL, LOOK AT THE PROBLEM AND ADVISE THEM AS TO WHAT NEEDS TO BE DONE TO ALLEVIATE THE PROBLEM. ALDERMAN SAM JONES SECONDED THE MOTION. ALL WERE IN FAVOR.

IT WAS BROUGHT TO THE ATTENTION OF THE COUNCIL THAT WE HAVE A PROBLEM WITH PARENTS NOT SUBERVISING THEIR CHILDREN AND THE CHILDREN ARE PLAYING IN THE HIGHWAY. (TERRY TANNER, LORETTA HUTCHISON, AND LARRY ARMENTROUT WERE MENTIONED). ALDERMAN VICKI ALLEN WAS ASKED TO TALK TO THE LAW ABOUT THIS MATTER AND ALSO ABOUT PEOPLE RUNNING THE STOP LIGHT. ALSO ASK ABOUT A CONSTABLE JURISDICTION, AND THE POSSIBILITY OF A PART TIME LAW HERE IN OAK GROVE.

ALDERMAN SAM JONES TOLD THE COUNCIL THAT HE HAD BEEN CONTACTED BY THE BALL TEAM ABOUT A DATE FOR A TOURNMANENT. THE BALL TEAM HAD PREVIOUSLY TOLD THE SADDLE CLUB THAT THE DATE WAS OPEN AND THE SADDLE CLUB HAD ALREADY MADE PLANS FOR THE DATE. ALDERMAN GARY HIGH MADE A MOTION TO PUT A 3" LINE FROM WATER MAIN TO HAYES" PROPERTY. ALDERMAN DEAN STANPHILL SÉCONDED. ALL WERE IN FAVOR.
