

OAK GROVE TOWN COUNCIL METING
DATE: NOVEMBER 2, 1992

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON NOVEMBER 2, 1992, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT - ALDERMAN DEAN STANPHILL, ALDERMAN SAM JONES, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, MAYOR JEAN MORGAN, TREASURER RUTH CALLEN, AND RECORDER PAT CARLTON. ALDERMAN GARY HIGH WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF MINUTES. THEY WERE APPROVED.

OLD BUSINESS- PUT SOLID WASTE PAYMENT ON HOLD UNTIL FURTHER STUDY. ALDERMAN SAM JONES CONTACTED EDWIN MC CREARY ABOUT THE SAFETY OF THE HEATER AND INSTALLATION OF SUCH. EDWIN SAID A VALVE NEEDS REPLACING AND WOULD BE APPROXIMATELY \$120.00 TO \$150.00 TO INSTALL. ALDERMAN SAM JONES MADE MOTION TO BUY A NEW ONE BECAUSE OF THE AGE OF AND COST TO MAKE READY TO USE WOULD BE TOO HIGH. HE SAID EDWIN HAS A HEATER AND WOULD SELL IT TO US FOR HIS COST OF \$249.50. EDWIN WILL BE CONTACTED ABOUT THE BUYING AND INSTALLING. HAROLD SOOTER WILL BE CONTACTED ABOUT DOING ANY ADDITIONAL WORK THAT HAS TO BE DONE. ALDERWOMAN VICKI ALLEN SECONDED. ALL MEMBERS VOTED IN THE AFFIRMATIVE.

PAT CARLTON IS TO SEE ABOUT GETTING A P.O.BOX FOR THE WATER DEPT AND THE FIRE DEPT.

A ~~0~~ TENTATIVE BUDGET WAS PRESENTED.

ALL MEMBERS VOTED IN THE AFFIRMATIVE TO CONTINUE LIFE INSURANCE.

NEXT ORDER OF BUSINESS WAS FOR WATER FOR ELMER BRASWELL'S PROPERTY. LARRY PLUMLEE TOLD RON IF THE DEPT CAN'T DO ANY DIFFERENT HE WILL ALLOW THEN TO GO IN FRONT OF HIS PLACE. THE COUNTY WILL LET US GO ON COUNTY RIGHT OF WAY. ALDERMAN SAM JONES MADE MOTION TO DO SO AND ALDERMAN DEAN STANPHILL SECONDED THE MOTION. ALDERMAN SAM JONES IS TO TALK TO RON ABOUT WHAT HE TOLD BRASWELL HE CAN DO HIMSELF AND ABOUT THE RULES AND REGULATIONS THAT HAVE TO BE MET AND THAT THE TOWN WILL PAY THE DIFFERENCE BETWEEN A 3" LINE AND A 6" LINE. WE WILL HAVE TO GET THE PERMIT FROM THE COUNTY.

ALDERMAN SAM JONES MADE A MOTION THAT PAT CARLTON BE ALLOWED TO GO TO CARR'S AND GET A DESK CHAIR FOR WATER DEPT. ALDERWOMAN VICKI ALLEN SECONDED THE MOTION. ALL MEMBERS VOTED IN THE AFFIRMATIVE.

ALDERMAN DEAN STANPHILL MADE MOTION TO ADJOURN. ALDERWOMAN
VICKI ALLEN SECONDED.
