

OAK GROVE TOWN COUNCIL MEETING
DATE: OCTOBER 5, 1992

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE AR., MET ON OCTOBER 5, 1992, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT- ALDERMAN SAM JONES, ALDERMAN GARY HIGH, ALDERMAN DEAN STANPHILL, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, MAYOR JEAN MORGAN, TREASURER RUTH CALLEN, AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE RECONITION OF DELEGATION. CONSTABLE FRANK DICKINSON WAS PRESENT. HE HAS TALKED TO STATE POLICE AND W.A. FERGUSON ABOUT THE UNSIGHTLY MESS OF OLD CARS PARKED AT THE PROPERTY OF W.A. FERGUSON. HE HAS BEEN SUCCESSFUL IN GETTING PART OF THEM REMOVED. FRANK WILL HELP THE TOWN IN ANY WAY HE CAN, HE HAS A POLICE RADIO. (CARROLL 19). HE IS ELECTED AND HAS POWER IN COUNTY AS A DEPUTY. ALDERWOMAN VICKI ALLEN HAS TALKED TO SOME RESIDENTS IN HOLIDAY ISLAND ABOUT THEIR NEIGHBORHOOD WATCH. FRANK SAID WE MIGHT NEED A NO LOITERING ORDINANCE.

THE BILLS WERE PRESENTED. ALDERMAN DEAN STANPHILL MADE MOTION TO PAY RE-NEWAL FEE TO BELONG TO MUNICIPAL LEAGUE. ALDERWOMAN VICKI ALLEN SECONDED. ALL MEMBERS VOTED IN THE AFFIRMATIVE. MAYOR MORGAN ASKED WHAT'S YOUR PLEASURE FOR PAYING OUR SHARE TO SOLID WASTE MANAGEMENT (FOR STUDY)? ALL MEMBERS VOTED IN THE AFFIRMATIVE.

ALDERMAN GARY HIGH MADE MOTION TO PASS ORDINANCE 43-92, FOR ASSESSING A 5 MILL TAX AGAINST THE REAL AND A 5 MILL TAX AGAINST PERSONAL PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN OF OAK GROVE FOR THE TAXABLE YEAR OF 1993. ALDERMAN DEAN SECONDED THE MOTION. ALL MEMBERS VOTED IN THE AFFIRMATIVE.

WATER SUPERINTENDANT RON HIGH GAVE HIS 30 DAY NOTICE OF REGISNATION AS TOWN WATER SUPERINTENDANT. EFFECTIVE AS OF TODAY. RODNEY NEWMAN IS INTERESTED IN THE JOB. RODNEY WAS CALLED AND CAME AND TALKED TO THE COUNCIL. ALDERWOMAN PAT DAVIS MADE MOTION TO HIRE RODNEY AND ALDERMAN SAM JONES SECONDED THE MOTION. ALL THE MEMBERS VOTED IN THE AFFIRMATIVE. RODNEY WILL BE PAID HALF SALARY FOR THE FIRST MONTH AND WILL GO WITH RON TO LEARN THE OPERATION OF THE WATER WORKS. RODNEY WAS ALSO ASKED TO BE THE PLUMBING INSPCTOR. HE WILL HAVE SCHOOLING FOR THIS.

ALDERWOMAN VICKI ALLEN MADE MOTION TO PURCHASE ENOUGH BLUE FIRE REFLECTORS TO INDICATE WHERE THE FIRE HYDRANTS ARE. THIS IS TO COME JOUT OF THE STREET FUND. ALSO TO PAY FOR THE CITY FIRE TRUCK TO BE LETTERED, AND THIS WILL COME OUT OF THE

GENERAL FUND. ALL MEMBERS VOTED IN THE AFFIRMATIVE.

THE NEXT ORDER OF BUSINESS WAS THE NEED TO HAVE THE WALL HEATER THAT IS TO BE INSTALLED IN THE TOWN HALL TO BE SAFETY CHECKED. ALDERMAN SAM JONES WILL HAVE EDWIN MC CREARY TO CHECK THIS.

PLUMBING PERMITS- ALL NEW BUILDINGS, \$20.00, \$10.00 FOR RUFF-IN INSPECTIONS AND \$10.00 FOR FINAL INSPECTION. TO HOOK ON TO THE WATER WILL REQUIRE A \$40.00 DEPOSIT, \$160.00 FOR METER AND SETTING OF SUCH, AND \$10.00 FOR EACH MONTH THE WATER HAS BEEN IN OPERATION. (INCLUDING THE MONTH OF MARCH 1992.

THE NEXT MEETING WILL BE MONDAY NOVEMBER 2, 1992, BECAUSE OF ELECTION DAY ON THE 3RD.

ALDERMAN SAM JONES MADE MOTION TO ADJOURN. ALDERWOMAN VICKI ALLEN SECONDED.
