

OAK GROVE TOWN COUNCIL MEETING
DATE: SEPTEMBER 1, 1992

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON SEPTEMBER 1, 1992, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT - ALDERMAN SAM JONES, ALDERMAN GARY HIGH, ALDERMAN DEAN STANDPHILL, ALDERWOMAN VICKIE ALLEN, ALDERWOMAN PAT DAVIS, TREASURER RUTH CALLEN, MAYOR JEAN MORGAN, AND RECORDER PAT CARLTON.

THE MINUTES WERE READ AND APPROVED FOR THE AUGUST 4, 1992 MEETING.

THE FIRST ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. ALDERMAN DEAN STANDPHILL MADE MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN SAM JONES SECONDED THE MOTION. ALL WERE IN FAVOR. ALDERMAN GARY HIGH MADE A MOTION TO RAISE THE INSURANCE ~~PREMIUM~~ ^{coverage} TO \$35,000.00. ALDERWOMAN VICKI ALLEN SECONDED. ALL WERE IN FAVOR.

THE NEXT ORDER OF BUSINESS WAS OLD BUSINESS. MAYOR MORGAN CONTACTED THE HARRISON HIGHWAY DEPT. CONCERNING THE WATER THAT STANDS IN THE DITCH WEST OF THE FIRE STATION AND WAS TOLD THAT THE HIGHWAY IS DOING ITS JOB AND THE PROBLEM IS ON THE PROPERTY OWNERS LAND. THE CITY COUNCIL WAS INSTRUCTED TO CONTACT THE PROPERTY OWNER ABOUT DRAINAGE.

IT WAS BROUGHT TO THE ATTENTION OF THE COUNCIL THAT THE COUNTY IS SUPPOSED TO PUT DIRT AT THE END OF THE COMMUNITY GROUNDS AND NOTHING HAS BEEN DONE AT THE PRESENT TIME.

ALDERWOMAN VICKI ALLEN MADE A MOTION TO GIVE TREASURER RUTH CALLEN A \$50.00 RAISE BRINGING HER SALARY UP TO \$100.00 FOR THE WATER WORKS AND \$100.00 FOR THE TOWN WORKS. IT WILL BE REVIEWED AGAIN WHEN RUTH GIVES UP THE POSITION OF TREASURER FOR THE WATER DEPARTMENT THE LAST OF DECEMBER. WATER CLERK PAT CARLTON SALARY WILL BE \$300.00 A MONTH AND WATER SUPERINTENDANT RON HIGH'S SALARY WILL BE \$300.00 A MONTH PLUS \$30.00 AN HOUR FOR BACK HOE WORK AND \$7.50 AN HOUR FOR FOOT WORK. THIS IS WORK UP AND ABOVE HIS DUTIES AS WATER SUPT. ALL THE COUNCIL WAS IN FAVOR.

THE COMMUNITY BUILDING IS NEEDING SOME REPAIRS. ALDERMAN VICKI ALLEN IS TO SEE JERRY BLACKSTON ABOUT WHAT THE BOYS CAN DO, THAT IS WORKING OFF COURT COMMITMENT, IN THE LINE OF WORK. ALDERWOMAN VICKI ALLEN MADE MOTION AND ALDERMAN DEAN STANDPHILL SECONDED TO ASK HAROLD SOOTER TO OVER SEE THE WORK AND DO THE NECESSARY WORK THAT THE BOYS ARE NOT ALLOWED TO DO, AND GET THE MATERIALS NEEDED FOR THE WORK. ALL WERE IN AGREEMENT.

THE MAYOR IS TO CALL PHIL JACKSON ABOUT THE PUTTING CHIP AND SEAL ON SOME OF THE ROADS IN THE TOWN. SOOTER ROAD AND ALLEN ROAD.

ALDERMAN GARY HIGH MADE MOTION TO ADJOURN. ALDERMAN DEAN STANDPHILL ~~SECONDED~~. ALL WERE IN FAVOR.
