

OAK GROVE TOWN COUNCIL MEETING
DATE APRIL 5, 1993

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, MET ON APRIL 5, 1993, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT - MAYOR JEAN MORGAN, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, ALDERMAN SAM JONES, ALDERMAN GARY HIGH, ALDERMAN DEAN STANPHILL, TREASURER RUTH CALLEN AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF THE LAST MONTHS MINUTES. MAYOR MORGAN ASKED FOR A VOTE FOR THE MINUTES TO BE ACCEPTED AS READ. ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT AND ALDERMAN DEAN SECONDED. ALL IN FAVOR SAY I. ALL VOTED IN THE AFFIRMATIVE.

NEXT ORDER OF BUSINESS WAS OLD BUSINESS. MAYOR MORGAN CALLED THE STATE HIGHWAY DEPT. ABOUT THE SPEED LIMITS SIGNS. THEY SAID THEY WOULD BE OUT AND CHECK BUT HAVE NOT BEEN OUT. SHE WILL CALL AGAIN. HAROLD SOOTER STILL HASN'T PUT A VENT IN THE TOWN HALL YET. ALDERMAN SAM JONES WILL SEE ABOUT IT. RODNEY NEEDS TO CHECK ABOUT A POSSIBLE LEAK AT THE FIRE HYDRANT NEAR FLOYD SOOTERS PLACE. ABOUT THE BALL PARK WORK. JERRY BLACKSTON WAS CONTACTED ABOUT THE PRISON COMMUNITY SERVICE BOYS DOING SOME OF THE WORK AND HE SAID THEY WOULD. THE DUG-OUTS NEEDS REPAIR. THE FIELD ALSO NEEDS BETTER WATER PRESSURE. ALDERMAN GARY HIGH MADE A MOTION TO PUT A LARGER LINE TO THE FIELD AND PUT A FIRE HYDRANT AND FLUSH STATION AT THE END. WILL NEED APPROXIMATELY 60 TO 80 FEET OF PIPE. THE BALL TEAM WILL PAY FOR FLUSH STATION LIKE THE SADDLE CLUB DID. THE TOWN WILL DO THE REST. BALL CLUB WILL HELP WITH WORK. THE FENCE AROUND PART OF THE BALL FIELD NEEDS TO BE EXTENDED TO 6' INSTEAD OF THE EXISTING 4'. A POLE FOR THE SMALLER KIDS TO PLAY BASKETBALL NEEDS TO BE SET. THE LEAVES NEED TO BE RAKED AWAY FROM THE FENCE, LIMBS PICKED UP AND BURNT. RODNEY NEWMAN CHECK AND SEE WHAT NEEDS TO BE DONE AND WHAT MATERIALS NEED TO BE BOUGHT. VICKI ALLEN SEE JERRY BLACKSTON ABOUT HIS BOYS DOING THE WORK AND WHEN THEY CAN COME, WORK NEEDS TO BE DONE AS SOON AS POSSIBLE. GARY HIGH GET SAND FOR THE SAND BOX. RODNEY NEWMAN OVERSEE THE WORK. ALDERMAN VICKI ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I, ALL VOTED IN THE AFFIRMATIVE. MONEY IS AUTHORIZED TO PAY BILLS. ALDERMAN GARY HIGH VOTED TO DO SO, ALDERWOMAN VICKI ALLEN SECONDED. ALL IN FAVOR SAY I. ALL VOTED IN THE AFFIRMATIVE.

RUTH CALLEN-CALL AND START THE DUMPSTER PICK UP AT THE COMMUNITY. NO-THE TOWN WILL NOT PAY TO HAVE SOME DUMPSTERS IN DIFFERENT LOCATIONS FOR THE USE OF THE RESIDENTS. LOCAL TRASH PICK UP IS PROVIDED BY HAULERS AND EACH RESIDENT CAN USE THESE FACILITIES. ALSO NOTIFY THE CARROLL ELECTRIC THAT SOME LIGHTS ARE OUT AT THE COMMUNITY BUILDING.

WANDA DAVIS WANTS DIRT PUT IN A HOLE LEFT WHEN WATER METERS WERE SET. SOME MORE HOLES ARE NEEDING FILL. ALL IN FAVOR OF RON HIGH DOING THE WORK SAY I. ALL VOTED IN THE AFFIRMATIVE.

A CLINIC HAS BEEN SET UP FOR THE 10TH AT THE COMMUNITY BUILDING FOR ~~VACCINATION~~ ^{VACCINIZATION} OF DOGS AND CATS, AND TO DRAW BLOOD FROM HORSES TO TEST FOR COGGINS.

DISCUSSION WAS MADE ON A POSSIBLE HOUSING ORDINANCE FOR THE TOWN. MAYOR MORGAN WILL SEE LEWIS EPLEY ABOUT WHAT CAN BE DONE.

ALDERMAN SAM JONES MADE A MOTION TO PAY RODNEY NEWMAN GAS MILEGE FOR ERRANDS HE RUNS FOR THE WATER DEPT. RODNEY WAS TOLD TO KEEP A TRACK OF MILEGE. HE IS GOING TO SCHOOL FOR A FEW DAYS AND GIVE HIM \$25.00 FOR GAS. ALDERWOMAN VICKI ALLEN SECONDED. ALL IN FAVOR SAY I. ALL VOTED IN THE AFFIRMATIVE. HE WAS PAID.

ALDERMAN DEAN STAMPHILL MADE MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED.
