

OAK GROVE TOWN COUNCIL MEETING

DATE: JAN. 4, 1993

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON JAN. 4, 1993, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT- MAYOR JEAN MORGAN, ALDERMAN DEAN STANPHILL, ALDERMAN SAM JONES, ALDERMAN GARY HIGH, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, TREASURER RUTH CALLEN AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF THE LAST MONTHS MINUTES. THEY WERE READ AND APPROVED OF AS READ.

THE BILLS WERE PRESENTED. ALDERWOMAN VICKI ALLEN MOVED TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN DEAN STANPHILL SECONDED. ALL MEMBERS VOTED IN THE AFFIRMATIVE.

NEW BUSINESS- ALDERMAN GARY HIGH MADE A MOTION THAT WE TAKE \$100.00 DOLLARS OUT OF THE GENERAL FUND AND GIVE TO THE FIRE DEPARTMENT. THEY NEED SUPPLIES TO GET THE DEPARTMENT UP TO RATINGS. ALDERWOMAN VICKI ALLEN SECONDED. ALL MEMBERS VOTED IN THE AFFIRMATIVE. ALDERMAN SAM JONES MADE A MOTION FOR ALL NON-MEMBERS OF THE FIRE DEPARTMENT TO PAY A MINIMUM OF \$250.00 + \$100.00 PER HOUR WITH A MAXIMUM OF \$1,000.00 FOR EACH FIRE CALL RESPONDED TO. ALDERMAN DEAN STANPHILL SECONDED. ALL IN FAVOR? 5 YES, 1 NO. CARRIED. MEMBERSHIP IS \$25.00 PER YEAR.

ALDERWOMAN VICKI ALLEN MADE A MOTION TO CALL R E A TO AUTHORIZE A LIGHT TO BE PUT ON THE POLE IN FRONT OF THE P.O. ALDERMAN SAM JONES SECONDED THE MOTION. ALL VOTED IN THE AFFIRMATIVE.
