OAK GROVE TOWN COUNCIL MEETING DATE: JULY 6,1993

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, MET ON JULY 6,1993 IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT, MAYOR JEAN MORGAN, ALDERWONAM 'PAT DAVIS, ALDERWOMAN VICKI ALLEN, ALDERMAN SAM JONES, ALDERMAN GARY HIGH, ALDERMAN DEAN STANPHILL, TREASURER RUTH CALLEN, AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. MINUTES WERE READ AND ALDERWOMAN PAT DAVIS MADE MOTION TO ACCEPT AS READ, ALDERMAN GARY HIGH SECONDED THE MOTION. ALL VOTED IN THE AFFIRMATIVE.

THE NEXT ORDER OF BUSINESS WAS OLD BUSINESS. THE RED LIGHT THAT THE COUNCIL VOTED ON TO HAVE PUT AT THE FIRE DEPARTMENT WILL BE TO ALERT THE FIRE MEN AS WELL AS FOR THE LOCATION OF THE FIRE HOUSE. THE CERTIFIED LETTER THAT WAS SENT TO GREERS CONSTRUCTION HAS HAD NO RESPONSE.

THE NEXT ORDER OF BUSINESS WAS THE RECONIGITION OF DELEGATION. TERRY HUTCHISON IS UPSET BECAUSE THE SADDLE CLUB HAS PAID TO HAVE A VALVE PUT AT THE ARENA AND CAN'T USE THE FIRE TRUCK TO WATER DOWN THE ARENA AND OTHER PEOPLE CAN USE IT TO FILL POOLS AND ETC. WHEN THE SADDLE CLUB WAS TOLD IT COULD NOT USE THE FIRE TRUCK TO WATRER DOWN THE ARENA THE TOWN DID NOT HAVE THE WATER SYSTEM IN OPERATION, THE FIRE TRUCK WAS USED TO WATER DOWN THE ARENA AND WAS LEFT EMPTY. THE FIRE DEPARTMENT GOT A CALL. THE TOWN COUNCIL AGREED THAT IT WAS A DANGER TO USE THE TRUCK FOR SUCH. NOW THAT WE HAVE WATER AVAILABLE, ALDERMAN DEAN STANPHILL MADE THE MOTION THAT WATER SUPERTENDANT RODNEY NEWMAN OVER SEE THE DISTRUBUTION OF WATER AND THE USE OF THE FIRE TRUCK. THE COST WILL BE \$15.00 PER 1,000 GALLONS. \$7.50 WILL GO TO THE WATER DEPARTMENT AND \$7.50 WILL GO TO THE DRIVER, THIS IS TO BE IN A FIVE MILE RADIUS AND AT THE DESCRETION OF THE WATER SUPERTINDENT. ALDERWOMAN VICKI ALLEM SECONDED. ALL IN FAVOR TWO OPPOSED. BILLY AND GINNY STEWART AND STANDLEE AND MARILYN ANDRESKT IS UPSET BECAUSE OF WATER DRAINAGE ON THEIR PROPERTY. THEY SAY LEANORD WOOD HAS TAKEN THE TIN HORN OUT OF THEIR DITCH THAT CARRIED THE WATER DOWN THE DITCH LINE AND THE WATER IS DIVERTED OVER TO THEIR PROPERTY. THE COUNTY JUDGE WAS SUPPOSED TO FIX THIS LAST YEAR BYT DID NOT CORRECT THE PROBLEM. THE COUNTY JUDGE WILL BE NOITIFIED AGAIN TO THE PROBLEM.

ALDERMAN DEAN STANPHILL MADE MOTION TO GIVE VICKI ALLEN \$175.00 TOWARD EXPENSES FOR MORE SCHOOLING IN LITTLE ROCK. ALDERMAN GARY HIGH SECONDED. ALL IN FAVOR ALL VOTED IN THE AFFIRMATIVE.

ALDERWOMAN PAT DAVIS PRESENTED TO THE TOWN COUNCIL AN

ORDIANCE PERTAINING TO THE UPKEEP OF THE TOWN. ALDERWONAN VICKI ALLEN WILL HAVE IT COPIED SO THAT ALL MEMBERS CAN READ AND SEE WHAT PERTAINS TO THE TOWN OF OAK GROVE FOR THE NEXT MEETING. ALDERMAN GARY HIGH MADE A MOTION THAT THE TOWN NEEDS AT LEAST THREE EXTRA LOADS OF GRAVEL TO PATCH THE ROADS AS NEEDED. ALDERMAN SAM JONES SECONDED, ALL VOTED IN THE AFFIRMATIVE.

WATER CLERK PAT CARLTON TOLD OF THE CHANGE IN THE WATER TESTING FEE. THE WATER TESTING FEE OF FIFTEEN CENTS THAT THE AR. HEALTH DEPARTMENT REQUIRES ON ALL PATRONS EXPIRED WITH THE JULY BILLING. WITH THE AUG. BILLING THEY WERE REQUIRING TWENTY FIVE CENTS PER PATRON. BECAUSE THE DEPARTMENT DIDN'T GET THINGS IN ORDER TO START THE AUG BILLING AND PART OF THE SEPT. BILLING, I CALLED THE AR. DEPT. OF HEALTH AND WAS TOLD NOT TO CHARGE FOR THE MONTH OF AUG. AND TO PRO-RATE THE MONTH OF SEPT. OF FIFTEEN CENTS AND TO THE START THE TWENTY FIVE CENT FEE ON OCT. BILLING. ALDERWOMAN PATTDAVIS MADE MOTION TO ACCEPT. ALDERMAN SAM JONES SECONDED THE MOTION. ALL VOTED IN THE AFFIRMATIVE.

ALDERMAN DEAN STANPHILL MADE MOTION TO ADJOURN, ALDERMAN SAM JONES SECON-DED. ALL IN FAVOR SAY I, ALL OPPOSED BY SAME, ALL VITS.
