

OAK GROVE TOWN COUNCIL MEETING
DATE: JUNE 1, 1993

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, MET ON JUNE 1, 1993, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT- MAYOR JEAN MORGAN, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, ALDERMAN SAM JONES, ALDERMAN GARY HIGH, TREASURER RUTH CALLEN AND RECORDER PAT CARLTON. ALDERMAN DEAN STANPHILL WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF THE PREVIOUS MONTHS MINUTES. MINUTES WERE READ AND ALDERMAN GARY HIGH MADE MOTION TO ACCEPT AS READ AND ALDERWOMAN VICKI ALLEN SECONDED. ALL VOTED IN THE AFFIRMATIVE.

THE NEXT ORDER OF BUSINESS WAS RECOGNITION OF DELEGATION. J. P. LARRY SWOFFORD AND CO. JUDGE PHIL JACKSON WAS PRESENT AND TALKED ABOUT THE BENEFITS THAT THE PROPOSED 1 CENT SALES TAX WOULD GENERATE. THE TOWN WOULD BE PAID A MONTHLY SUM BASED ON PER CAPITA SHARE. MAYOR MORGAN THINKS THE COUNCIL SHOULD PUSH FOR PASSAGE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF BILLS. ALDERMAN GARY HIGH MADE MOTION TO ALLOCATE MONEY TO PAY THE BILLS AND ALDERWOMAN VICKI ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I, ALL SAID I. WATER SUPERINTENDENT RODNEY NEWMAN NEEDS AN EXTRA \$50.00 FOR OVERTIME SPENT ON HIS JOB. ALDERWOMAN VICKI ALLEN MADE MOTION TO DO SO AND ALDERMAN SAM JONES SECONDED. ALL IN FAVOR I. ALL WERE IN FAVOR. ALDERWOMAN VICKI ALLEN SAID THE FIRE DEPARTMENT THINKS A RED LIGHT, DESIGNATING LOCATION OF THE FIRE DEPARTMENT, BE ERRECTED ON THE FRONT OF THE FIRE BUILDING. ALDERWOMAN VICKI ALLEN MADE MOTION TO DO SO AND ALDERMAN SAM JONES SECONDED. ALL VOTED IN THE AFFIRMATIVE. ALDERWOMAN VICKI ALLEN AND TREASURER RUTH CALLEN TALK TO LARRY GINN AND DOUG JOHNSON ABOUT USED RADIOS FOR THE FIRE DEPARTMENT.

RESOLUTION 44-93 WAS PRESENTED BEFORE THE COUNCIL. ALDERMAN GARY HIGH MADE MOTION TO ACCEPT THE RESOLUTION. ALDERWOMAN VICKI ALLEN SECONDED. ALL IN FAVOR I. ALL I'S.

GREER CONSTRUCTION OF GREEN FOREST WHO RECIEVED PAYMENT FROM THE TOWN OF OAK GROVE FOR WORK ON THE WATER DEPARTMENT AND FROM BB&B. ~~HE~~ HAS BEEN NOTIFIED BY THIS DEPARTMENT ASKING FOR A REIMBURSEMENT FOR THE OVERPAYMENT AND WE HAVE HAD NO RESPONSE. MAYOR MORGAN, SEND HIM A BILL BY CERTIFIED MAIL TELLING HIM IF HE DOES NOT RESPOND WITHIN 30 DAYS THE BILL WILL BE TURNED OVER TO THE SMALL CLAIMS COURT. ALDERWOMAN PAT DAVIS MADE MOTION TO SEND THE LETTER AND ALDERMAN GARY HIGH SECONDED. ALL VOTED IN THE AFFIRMATIVE.

ALDERWOMAN VICKI ALLEN MADE A MOTION TO LET GARY HIGH DO

MAINTAINCE FOR THE WATER DEPARTMENT IF AND WHEN RON HIGH CANNOT GET TO THE JOB IN A REASONABLE TIME. ALDERWOMAN PAT SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL WERE IN FAVOR.

ALDERWOMAN PAT DAVIS THINKS THE TOWN NEEDS SOME KIND OF ORDINANCE FOR THE UPKEEP OF THE TOWN. PAT WORK ON A COMMITY TO HELP. CALL OTHER MAYORS AND FIND OUT WHAT THEY HAVE FOR THE SETTING OF TRAILOR HOMES.

ALDERWOMAN PAT DAVIS MADE A MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED. ALL VOTED IN AFFIRMATIVE.
