

OAK GROVE TOWN COUNCIL MEETING  
DATE: MAY 4, 1993

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, MET ON MAY 4, 1993, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT- MAYOR JEAN MORGAN, ALDERMAN PAT DAVIS, ALDERWOMAN VICKI VICKI ALLEN, ALDERMAN SAM JONES, ALDERMAN DEAN STANPHILL, TREASURER RUTH CALLEN. AND RECORDER PAT CARLTON. ALDERMAN GARY HIGH WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF THE PREVIOUS MONTHS MINUTES. MINUTES WERE READ AND APPROVED AS READ. ALDERMAN DEAN STANPHILL MADE MOTION AS TO ACCEPT AND ALDERWOMAN VICKI ALLEN SECONDER. ALL VOTED IN THE AFFIRMATIVE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF BILLS. ALDERWOMAN VICKI ALLEN VOTED THAT MONEY BE ALLOCATED TO PAY THE BILLS AND ALERMAN SAM JONES SECONDED. ALL MEMBERS VOTED IN THE AFFIRMATIVE.

THE NEXT ORDER OF BUSINESS WAS OLD BUSINESS. THE SAND WAS DELIVERED AND PUT IN THE SAND BOX BUT THE COUNCIL IS NOT PLEASED WITH THE SAND AS IT IS MORE LIKE GRAVEL. SEE GARY HIGH ABOUT TAKING IT OUT AND PUTTING FINER SAND IN. ALDERWOMAN VICKI ALLEN GAVE A REPORT ON PLAYGROUND EQUIPMENT THAT JERRY BLACKSTON HAD DRAWN UP. JERRY CAME IN LATER AND GAVE A MORE DETAILED REPORT. THE EQUIPMENT IS MADE OUT OF OSMOSIS, SMALL ONE IS AROUND \$250.00 AND LARGER ONE IS AROUND \$600.00. ALDERMAN DEAN STANPHILL MADE MOTION TO GET THE LARGER SIZE TO BE CONSTRUCTED AS SOON AS POSSIBLE. ALDERWOMAN PAT DAVIS SECONDED, ALL VOTED IN THE AFFIRMATIVE. JERRY BLACKSTON WILL OVER SEE THE WORK WITH THE BOYS FROM THE PRISON COMMUNITY SERVICE DOING THE WORK. LUMBER, PAINT AND CHAIN LINK FENCE WILL BE BJOUGHT AT HANBY LUMBER. THE PLAYGROUND EQUIPMENT WILL BE PUT OUT FRONT OF THE COMMUNITY GROUNDS. ALSO PUT THE PICNIC TABLES OUT IN FRONT. GARY HIGH SEE ABOUT PUTTING THE GRAVEL THAT YOU TAKE OUT OF THE SAND BOX AND PUT IT UNDER THE PLAYGROUND EQUIPMENT. THE COUNTY WILL HAUL THE REST OF THE PEA GRAVEL THAT NEEDS TO BE PUT OUT AT NO COST. WE WILL HAVE TO PAY FOR THE GRAVEL. ALL THE COUNCIL VOTED IN THE AFFIRMATIVE FOR THIS TO BE DONE. THE FENCE HASN'T BEEN PUT UP YET. ALDERMAN SAM JONES MADE A MOTION THAT THE FENCE THAT IS TO BE TAKEN DOWN BE PUT UP AROUND THE PLAYGROUND AREA. ALDERWOMAN VICKI ALLEN SECONDED. ALL VOTED IN THE AFFIRMATIVE. ALDERWOMAN VICKI ALLEN MADE A MOTION TO HAVE JERRY BLACKSTON AND HIS BOYS BUY AND INSTALL MINI-BLINDS AT THE COMMUNITY BUILDING WINDOWS. ALDERWOMAN PAT DAVIS SECONDED. ALL THE MEMBERS VOTED IN THE AFFIRMATIVE. THE CHAIN LINK FENCE WILL RUN AROUND \$336.05.
