

OAK GROVE TOWN COUNCIL MEETING
DATE: NOV. 2, 1993

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, MET ON NOV. 2, 1993, FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT--MAYOR, JEAN MORGAN, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, ALDERMAN SAM JONES, ALDERMAN DEAN STANPHILL, TREASURER RUTH CALLEN, AND REPORTER PAT CARLTON. ALDERMAN GARY HIGH WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES, THE MINUTES WERE READ. ALDERMAN DEAN STANPHILL MADE MOTION TO ACCEPT THE MINUTES AS READ, ALDERWOMAN VICKI ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I, ALL OPPOSED BY SAME. ALL VOTED TO ACCEPT.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. DO WE WANT TO PAY THE DUES TO THE NORTHWEST ARKANSAS ECONOMIC DEVELOPMENT DISTRICT? ALDERMAN SAM JONES MADE MOTION TO PAY. ALDERMAN DEAN STANPHILL SECONDED THE MOTION. ALL IN FAVOR SAY I, ALL OPPOSED BY THE SIGN. ALL VOTED IN THE AFFIRMATIVE.

OLD BUSINESS: GREER CONSTRUCTION CO. PAID THE BILL FOR \$151.94 TO THE WATER DEPT HE HAS OWED FOR SOME TIME.

ALDERWOMAN PAT DAVIS MADE MOTION TO AMMEND THE BUDGET AND TAKE WHAT WAS BUDGETED FOR PARKS AND RECREATION (WE DID NOT SPEND WHAT WAS ORIGINALLY BUDGETED) AND PUT IT IN THE FIRE DEPARTMENT COLUMN. (\$2,7500.00) ALDERWOMAN VICKI ALLEN SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED SAY I. ALL SAID I.

NEW BUSINESS: ALDERMAN SAM JONES AND FIRE CHIEF FRANK ALLEN GAVE A REPORT ON WHAT THEY HAD LEARNED AT THE SEMINAR/WORKSHOP THEY ATTENDED. THEY WERE ADVISED THAT A CITY COUNCIL MEMBER NOT BE ON THE FIRE DEPARTMENT. THEY TALKED ABOUT THE RETIREMENT FOR THE FIRE DEPARTMENT MEMBERS. WE WILL WORK ON PLANS AND PRESENT THEM LATER.

MR. L. D. STORDAL WAS PRESENT AND PRESENTED A LETTER HE HAS SENT TO THE COUNTY JUDGE, REQUESTING HIM TO INVOKE JURISDICTION OVER THE MT. ZION CHURCH, IN OAK GROVE, AND THAT MR STORDAL AND RANDY SOOTER BE APPOINTED TRUSTEES IN REGARD TO SAID PROPERTY. THE TRUSTEES THAT WERE ORIGINALLY ON THE DEEDS ARE DECEASED. MR. STORDOL AND RANDY SOOTER SAYS IT HAS NO LEGAL OWNERS. MR. STORDOL ALSO PRESENTED A COPY OF A REQUEST THAT HE HAS GIVEN TO THE POSTMASTER REQUESTING THE U.S. POSTAL SERVICE TO ADJUST THE ZIP CODE BOUNDARY FOR THE TOWN OF OAK GROVE.

TREASURER RUTH CALLEN PRESENTED A TENTATIVE BUDGET TO THE COUNCIL, SHE WILL HAVE THE 1994 ONE AT NEXT MONTHS MEETING.

ALDERMAN DEAN STANPHILL MADE MOTION TO CONTACT SOMEONE WITH

ALDERMAN DEAN SLAVINOFF MADE MOTION TO CONVICT SOMEONE WITH
