THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET  
AT 7:00 P.M. AT THE TOWN HALL FOR A SPECIAL CALLED MEETING.

THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A  
QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT.  
ALDERWOMEN VICKI ALLEN AND PAT DAVIS, ALDERMEN SAM JONES, DEAN  
STANPHILL AND GARY HIGH, TREASURER RUTH CALLEN AND RECORDER PAT  
CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF AUGUST 2 MEETING.  
ALDERMAN SAM JONES MADE A MOTION TO ACCEPT THE MINUTES AS READ,  
ALDERWOMAN VICKI ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I,  
ALL SAID I.

MAYOR MORGAN READ ORDINANCE 47-94, CALLING FOR A SPECIAL ELECTION  
FOR A 1 CENT SALES TAX. ALDERMAN DEAN STANPHILL MADE A MOTION TO  
PASS ORDINANCE 47-94 CALLING FOR A SPECIAL ELECTION. ALDERWOMAN  
VICKI ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY AYE. ALL SAID  
AYE. MAYOR MORGAN READ A PROCLAMATION (OFFICE OF THE MAYOR)  
CONCERNING THE 1 CENT SALES TAX.

STEVE ALLEN IS GIVEN AUTHORIZATION TO MAKE WATER DELIVERIES IF  
RODNEY NEWMAN IS UNABLE TO DO SO.

ALDERMAN SAM JONES MADE MOTION TO GIVE FIR CHIEF FRANK ALLEN \$300.00  
FOR EXTRA WORK HE HAS GIVEN TO THE FIRE DEPARTMENT AND FOR TRIPS  
HE HAS MADE. ALDERMAN DEAN STANPHILL SECONDED THE MOTION. ALL IN  
FAVOR SAY I. ALL SAID I.

ALDERMAN SAM JONES SAYS WE NEED A COPIER. MAYOR MORGAN SAID FOR THE  
COUNCIL TO CHECK ON PRICES.

ALDERMAN DEAN STANPHILL GAVE HIS RESIGNATION FOR HIS POSITION  
#2 ON THE TOWN COUNCIL, HE IS MOVING OUT OF THE TOWN LIMITS AND
