

OAK GROVE TOWN COUNCIL MEETING
DATE DECEMBER 6, 1994

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET DECEMBER 6, 1994 IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED.
