

OAK GROVE TOWN COUNCIL MEETING

DATE: FEBRUARY 1, 1994

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, MET ON FEB. 1 FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT. MAYOR JEAN MORGAN, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, ALDERMAN SAM JONES, ALDERMAN DEAN STANPHILL, ALDERMAN GARY HIGH, TREASURER RUTH CALLEN AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ALDERMAN SAM JONES MADE MOTION TO ACCEPT AS READ. ALDERMAN GARY HIGH SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL VOTED I.

THE BATHROOMS AT THE COMMUNITY BUILDING NEEDS REPAIRED. SEE HAROLD SOOTER ABOUT DOING THE WORK. SAM JONES WILL. RODNEY NEWMAN SEE IF JACK NEWMAN WILL REPAIR THE PLAYGROUND EQUIPMENT. RODNEY SEE ABOUT GETTING THE GRAFFITI OFF OF THE WATER TOWER. SOME GRAVEL NEEDS TO BE PUT IN THE DRIVE WAY OF THE DANIEL FOSTERS HOME THIS WILL COME OUT OF THE STREET FUND. ALDERWOMAN VICKI ALLEN MADE MOTION TO SEND NECESSARY PAPERS TO SEN. FITCH AND GET THE LEGALITIES OF IT. ALDERWOMAN PAT DAVIS SECONDED. ALL IN FAVOR SAY I. ALLOPPOSED BY THE SAME. ALL VOTED I.

ALDERMAN SAM JONES MADE A MOTION TO GIVE THE EMPLOYEES A RAISE. \$100.00 TO WATERSUPERTENDENT RODNEY NEWMAN. BRING STEVE ALLENS WAGES UP TO \$100.00 PER MONTH, GIVE RUTH CALLEN AND PAT CARLTON A \$75.00 INCREASE. ALDERMAN GARY HUGH SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL VOTED I.

RODNEY NEWMAN WAS CONTACTED BY JIMMY MCINTOSH ABOUT THE BALL PARK FOR THE SEASON. HAVE JIMMY MET WITH THE COUNCIL AT NEXT MONTHS MEETING.

ALDERMAN DEAN STANPHILL MADE MOTION TO GIVE VICKI ALLEN AND FAITH PARTON EACH \$15.00 TO ATTEND A FIRST RESP ONSE CONFERENCE. ALDERMAN SAM JONES SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL VOTED I.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN. ALDERMAN DEAN STANPHILL SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL VOTED I.
