The Oak Grove Town Council of the town of Oak Grove, Arkansas met on February 7, 1995 at 7:00 p.m. in the town hall for a regular meeting. The meeting was called to order by Mayor Jean Morgan, presiding officer, and a quorum was established.

On roll the call the following members were present - Mayor Jean Morgan, Alderwomen Pat Davis and Vicki Allen, Aldermen Sam Jones, Willard Standlee and Gary High. Treasurer and Recorder Pat Carlton was absent and the reading of last months minutes were not read.

The first item of business was the reading of "Order of Confirmation of Annexation." from Judge Jackson.

The next item of business was the presentation of delegation. Lawyer Lewis Eply and Dave Tippet were present to talk about annexation of building project that Tippet plans to construct. Mr. Eply read Ordinance 50-94, "An ordinance annexing certain territories to the city of Oak Grove, Ar.", in its entirety. Due to the emergency nature of the Ordinance, the rule of reading an ordinance on three separate dates was suspended, and the ordinance was placed for three readings on February 7, 1995. Ordinance 50-94 was passed with a vote of 5 ayes and 0 nays. See excerpt for motions and votes taken.

The next order of business was the presentation of bills. Alderman Gary High made a motion to pay the insurance on the pump house. Alderwoman Vicki Allen seconded the motion. All in favor say I. All voted in the affirmative. Alderwoman Vicki Allen made a motion to allocate money to pay the regular monthly bills. Alderman Sam Jones seconded the motion. All in favor say I. All said I.

Alderman Gary High is to see someone about repairing the stop light.

Clell Standlee has asked permission to get water to a trailor house he is putting on his property. Alderman Sam Jones made motion to let him have water. Alderwoman Vicki Allen seconded the motion. All in favor say I. All said I.

Water Superintendent Rodney Newman is now a certified Class C Water Operator.

Alderwoman Pat Davis made a motion to adjourn. Alderman Sam Jones seconded the motion. All members voted in the affirmative. The meeting adjourned at 9:30 p.m. The next scheduled meeting is Tuesday March 7, 1995.
