

OAK GROVE TOWN COUNCIL MEETING
DATE: JANUARY 4, 1994

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET ON JANUARY 4, 1994 FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT...ALDERMAN SAM JONES, ALDERMAN DEAN STANPHILL, ALDERMAN GARY HIGH, ALDERWOMAN PAT DAVIS, ALDERWOMAN VICKI ALLEN, TREASURER RUTH CALLEN, AND RECORDER PAT CARLTON.
