

OAK GROVE TOWN COUNCIL MEETING
DATE: NOVEMBER 1, 1994

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, MET ON NOVEMBER 1, 1994 FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED.
