

OAK GROVE TOWN COUNCIL MEETING  
DATE: SEPTEMBER 6, 1994

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET AT 7.00 P.M. AT THE TOWN HALL FOR A REGULAR MEETING.

THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT.
