

OAK GROVE TOWN COUNCIL MEETING MINUTES  
DATE: APRIL 4, 1995

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET ON APRIL 4, 1995, AT 7:00 P.M. IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT: MAYOR JEAN MORGAN, ALDERWOMEN: PAT DAVIS AND VICKI ALLEN, ALDERMEN: SAM JONES, WILLARD STANDLEE, AND GARY HIGH, AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. RECORDER PAT CARLTON READ THE MINUTES. ANY CORRECTIONS OR OMISSIONS? ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERWOMAN VICKI ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL SAID I.

ALDERMAN SAM JONES MADE A MOTION TO DO THIS. ALDERWOMAN VICKI ALLEN SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL SAID I.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE REGULAR BILLS. ALDERWOMAN VICKI ALLEN MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL SAID I.

THE CARROLL CO. HEALTH UNIT IS INTERESTED IN GIVING A HEALTH SCREENING AT THE COMMUNITY BUILDING. ALDERWOMAN VICKI ALLEN IS TO GET IN TOUCH WITH THE HEALTH UNIT TO SET A DATE.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN. ALDERWOMAN VICKI ALLEN SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL SAID I. MEETING ADJOURNED AT 9:00 P.M.
