OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: FEBRUARY 26, 1996

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON FEBRUARY 26, 1996, AT THE TOWN HALL FOR A SPECIAL CALLED MEETING FOR THE ENACTMENT OF ORDINANCE NO. 52-96. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN SAM JONES, WILLARD STANDLEE AND GARY HIGH. ALDERWOMEN PAT DAVIS AND VICKI ALLEN. RECORDER PAT CARLTON.

MAYOR MORGAN READ AN AGREEMENT THAT IS SET UP BETWEEN SHE AND KENT COXEY. ALDERMAN SAM JONES MADE THE MOTION, " I MOVE THAT THE COUNCIL APPROVE THE SIGNING OF THE AGREEMENT BETWEEN MAYOR MORGAN AND THE HONORABLE KENT COXEY". ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. MR. COXEY IS TO SERVE AS THE DESIGNATED JUDGE OF THE CITY COURT OF THE TOWN OF OAK GROVE.

ALDERMAN WILLARD STANDLEE MADE A MOTION TO GIVE THE MAYOR A SALARY AND LOCK IN A YEARLY COST OF LIVING INCREASE, ALSO LOCK IN A YEARLY COST OF LIVING INCREASE FOR ALL SALARIED EMPLOYEES, EQUAL TO SOCIAL SECURITY C.O.L.A. EFFECTIVE APRIL 1ST 1996. SALARY WILL BE DISCUSSED LATER. ALDERWOMAN PAT DAVIS SECONDED THE MOTION. ALL VOTED IN THE AFFIRMATIVE.

MAYOR MORGAN READ ORDINANCE NO. 52-96 AS REQUIRED. ALDERMAN SAM JONES MADE MOTION TO ACCEPT. ALDERMAN GARY HIGH SECONDED. ALL IN FAVOR SAY I. ALL SAID I. *The motion to pass ordinance # 52-96 is attached.*

ALDERWOMAN VICKI ALLEN MADE MOTION TO ADJOURN. ALDERWOMAN PAT DAVIS SECONDED. ALL IN FAVOR SAY I. ALL SAID I. NEXT MEETING WILL BE THE REGULAR SCHEDULED MEETING FOR MARCH 5, 1995. MEETING ADJOURNED AT 8:30.
