

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: JULY 3, 1995

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON JULY 3, 1995 AT 7:00 P.M., IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED.
