

OAK GROVE TOWN COUNCIL MEETING MINUTES

DATE: JUNE 6, 1995

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET ON JUNE 6, 1995, AT 7:00 P.M., IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT: MAYOR JEAN MORGAN, ALDERMEN SAM JONES, WILLARD STANDLEE, AND GARY HIGH, ALDERWOMEN PAT DAVIS AND VICKI ALLEN, RECORDER PAT CARLTON, AND WATER SUPERINTENDANT RODNEY NEWMAN.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. THE MINUTES WERE READ. "ANY CORRECTIONS OR OMISSIONS"? ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. "ALL IN FAVOR SAY I". ALL COUNCIL SAID "I".

ALDERWOMAN VICKI ALLEN TALKED TO THE COUNCIL ABOUT SOME REQUIREMENTS THE COMMITTEE IS REQUESTING FOR FIREMEN TO BE ELIGIBLE FOR THE RETIREMENT FUND.

ALDERMAN SAM JONES MADE A MOTION TO AUTHORIZE VICKI ALLEN TO MAKE UP A FIRST RESPONERS KIT. ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. ALL RESPONSED WITH AYE.

RECIEVED A STREET LIGHTING AGREEMENT FROM CARROLL ELECTRIC FOR THE INSTALLATION OF A STREET LIGHT TO BE INSTALLED ALONG HIGHWAY 21 NEAR THE GENE REYNOLDS RESIDENCE.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN, ALDERWOMAN VICKI ALLEN SECONDED THE MOTION. ALL VOTED IN FAVOR. MEETING ADJOURNED AT 9:00 P.M.
