

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: MAY 2, 1995

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR. MET ON MAY 2, 1995, AT 7:00 P.M., IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT: MAYOR JEAN MORGAN, ALDERMEN SAM JONES, WILLARD STANDLEE, AND GARY HIGH, ALDERWOMEN PAT DAVIS AND VICKI ALLEN, RECORDER PAT CARLTON, AND WATER SUPERINTENDANT RODNEY NEWMAN.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL SAID I.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE TRACTOR NEEDS TIRES, PAY THE INSURANCE FOR THE FIRE FIGHTERS. WILLARD STANDLEE MAKE A TOP TO SET ON FILE CABINETS FOR A DESK TO BE USED FOR THE TOWN. ALDERMAN GARY HIGH MADE A MOTION TO ALLOCATE MONEY TO PAY THE REGULAR BILLS AND FOR TIRES, INSURANCE AND DESK. ALDERWOMAN VICKI ALLEN SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED BY THE SAME. ALL SAID I.

RODNEY NEWMAN WANTS TO BUILD A NEW HOUSE. WANTS PERMISSION TO USE THE STREET BEHIND THE ARENA TO GET TO THE PROPERTY. YES, HE HAS PERMISSION. THE STREET NEEDS GRAVEL, THE STREET FUND WILL PAY FOR THE GRAVEL.

CALL AMERICAN WASTE AND TELL THEM TO PUT A DUMPSTER AT THE COMMUNITY BUILDING.

IF A METER HAS NEVER BEEN SET AT PROPERTY OF CUSTOMERS THAT HAVE FULFILLED THE WATER USERS AGREEMENT THEN NO RECONNECT FEE WILL BE CHARGED WHEN AND IF THEY GO BACK IN THE SYSTEM. ONLY A WATER DEPOSIT PLUS ANY OUTSTANDING BILLS.

NEED TO TALK TO CARROLL ELECTRIC ABOUT PUTTING PIG TAILS ON THE LIGHT POLES FOR CHRISTMAS DECORATIONS. RODNEY CALL BRIAN AYERS AND ASK HIM TO COME TO CITY COUNCIL MEETING NEXT MONTH.

PAT DAVIS HAS ACCEPTED THE TOWNS BID OF \$10,000.00 FOR THE PROPERTY NEXT TO THE FIRE HOUSE. THERE IS APPROXIMATELY 1 1/2 ACRE. ALDERMAN SAM JONES MADE A MOTION THAT WE PURCHASE IT, ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. ALL IN FAVOR SAY I, ALL OPPOSED BY THE SAME. ALL SAID I. ALDERWOMAN PAT DAVIS ABSTAINED FROM VOTING.

ALDERWOMAN VICKI ALLEN MADE MOTION TO ADJOURN, ALDERMAN
WILLARD STANDLEE SECONDED. ALL IN FAVOR SAY I. ALL OPPOSED
BY THE SAME. ALL SAID I. MEETING ADJOURNED AT 9:00 P.M.
