

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: NOVEMBER 7, 1995

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON NOVEMBER 7, 1995, AT 7:00 P.M., THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN SAM JONES, AND WILLARD STANDLEE, ALDERWOMEN PAT DAVIS AND VICKI ALLEN AND RECORDER PAT CARLTON. ALDERMAN GARY HIGH WAS ABSENT.

THE MINUTES FOR THE OCTOBER 3, 1995 MEETING WERE READ. THERE BEING NO CORRECTIONS OR ALTERATIONS, MAYOR MORGAN ASK FOR A MOTION. ALDERWOMAN VICKI ALLEN MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. ALL MEMBERS VOTED IN THE AFFIRMATIVE, AND THE MINUTES WERE APPROVED AS READ.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. ALL VOTED IN THE AFFIRMATIVE.

MAYOR MORGAN READ A LETTER THAT SHE HAD RECEIVED FROM LEWIS EPLEY ON RESEARCH AND A LETTER OF OPINION ON ORDINANCE NO. 20 CONCERNING EMUS. AFTER DISCUSSION IT WAS DECIDED TO GET PROPER PAPERS TOGETHER AND TO SEND A LETTER TO THE MARVIN PHILLIPS FAMILY REQUESTING THEY MEET WITH THE TOWN COUNCIL AT THE NEXT MEETING FOR A DISCUSSION OF THE MATTER.

A CHECK FOR \$600.00, WAS GIVEN TO FIRE CHIEF FRANK ALLEN, TO PAY THE FCC LICENSE FOR THE FIRE DEPARTMENT.

THE PROPOSED BUDGET WAS PRESENTED TO THE COUNCIL FOR APPROVAL. COUNCILMAN SAM JONES MADE A MOTION TO ACCEPT THE PROPOSED BUDGET. ALDERMAN WILLARD STANDLEE SECONDED. ALL IN FAVOR? ALL VOTED I. WILL HAVE THE BUDGET READY FOR FINAL ADOPTION AT THE NEXT MEETING.

ALDERWOMAN VICKI ALLEN MADE A MOTION TO ADJOURN. ALDERWOMAN PAT DAVIS SECONDED. ALL MEMBERS VOTED IN THE AFFIRMATIVE. THE NEXT REGULAR MEETING WILL BE DECEMBER 5, 1995.
