OAK GROVE TOWN COUNCIL MEETING MINUTES DATE: AUGUST 2,1996

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MEETING ON AUGUST 2,1996, AT 7:00 P.M., IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER AND A QUORUM WAS ESTABLISHED.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. THE MINUTES WERE READ. ANY CORRECTIONS OR OMISSIONS? THE MAYOR ASK FOR A MOTION TO ACCEPT THEM AS READ. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO TERMINATE THE MAYORS SALARY AND MAKE IT AN EXPENSE ACCOUINT AS OF JULY 31,1996. ALDERMAN GARY HIGH SECONDED. ALL IN FAVOR SAY I. ALL SAID I.

NEXT ORDER OF BUSINESS WAS THE MAYORS REPORT. HAS ANYONE LOOKED AROUND THE COMMUNITY BUILDING TO SEE IF ANYTHING NEEDS TO BE DONE? I WENT UP AND IT LOOKS LIKE A GENERAL CLEANING NEEDS TO BE DONE AND I DID NOT REACH THE LADY IN BERRYVILLE THAT IS OVER THE GROUP THAT DOES THIS KIND OF WORK FOR THE COUNTY AND I TALDED TO COUNTY JUDGE PHIL JACKSON AND HE SAID THAT IS THE PLACE TO GET SOME HELP. HE HAD OPEN HOUSE AT THE COMMUNITY BUILDING ONE NIGHT LAST MONTH (FORGOT THE DATE). THERE WAS A DISCUSSION ABOUT THE LIGHTS AT THE COMMUNITY BUILDING. THE MAYOR SAID IT WOULD HAVE TO BE CHECKED INTO AND SEE IF A LIGHT IS NEEDED AND HOW CLOSE THE NEAREST LIGHT IS TO HIM.

THE MAYOR GAVE OUT INDEPENDENT CANDIDATE PETITION OF NOMINATION FORMS AND EXPAINED HOW TO FILL THEM OUT.

THERE WAS MUCH DISCUSSION ABOUT THE EMUS. CHESTER LAWRENCE

AND HIS WIFE WERE PRESENT AND TALKED ABOUT THEIR INTEREST IN THE PHILLIPS RAISING EMUS FOR THEM. LINDA AND MARVIN PHILLIPS WERE PRESENT. BONNIE OTT, MR. AND MRS MARVIN G. PHILLIPS, MR. AND MRS.
