

OAK GROVE TOWN COUNCIL MEETING MINUTES  
DATE: DECEMBER 3, 1996

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MEETING ON DECEMBER 3, 1996, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN GARY HIGH, WILLARD STANDLEE AND SAM JONES. ALDERWOMEN PAT DAVIS AND VICKIE ALLEN, AND RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF NOVEMBERS MINUTES. THE MINUTES WERE READ. ANY CORRECTIONS OR OMISSIONS? NONE. THE MAYOR ASKED FOR A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN WILLARD STANDLEE MADE A MOTION TO ACCEPT AS READ, ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. OPPOSED BY THE SAME, NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. A BILL FOR ACCIDENTAL DEATH INSURANCE FROM THE MUNICIPLE LEAGUE, INSURANCE FOR THE 1954 INTERNATIONAL FIRE TRUCK, STATE HIGHWAY BOND, A BILL TO AR. RURAL WATER ASSOCIATION, A BILL FROM LAWYER LEWIS EPLEY, AND THE REGULAR MONTHLY BILLS. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. ALL OPPOSED BY THE SAME. NONE.

THE TOWN BUDGET WAS PRESENTED. ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE BUDGET, ALDERMAN WILLARD STANDLEE SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. ALL OPPOSED BY THE SAME. NONE.

A DISCUSSION FOLLOWED. MAYOR MORGAN WILL CALL CARROLL ELECTRIC ABOUT PUTTING THE CHRISTMAS LIGHTS UP. SEE THE COUNTY ABOUT PATCHING SOME POT HOLES IN THE STREETS. ALDERMAN GARY HIGH HAS PERMISSION TO GET A LOAD OF GRAVEL FOR EMERGENCY USE. ALDERMAN SAM JONES SEE ABOUT SOME ONE FIXING THE FENCE AT THE COMMUNITY BUILDING THAT HAS BEEN VANDLEIZED AND SEE IF ANY THING CAN BE PUT UP TO DISCOURAGE VANDLES.

THE 1954 INTERNATIONAL FIRE TRUCK IS ABSOLETE, THE PUMPER IS TOO SMALL. IT HAS TO HAVE A CLASS A PUMPER. FIRECHIEF FRANK ALLEN IS LOOKING FOR A TRUCK.

THE WATER DEPARTMENT BUDGET WAS PRESENTED. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT. ALDERMAN ~~SAM JONES~~ *Willard Standlee* SECONDED THE MOTION. ALL IN FAVOR SAY I, ALL SAID I. ALL OPPOSED BY THE SAME. NONE.

RECORDER PAT CARLTON ASK *IF* SHE COULD GET SOME HELP WITH FILLING OUT TAX REPORTS. YES, USE YOUR OWN DESCRECTION ON WHO TO USE.

MAYOR MORGAN ATTENDED A COUNTY WIDE MEETING, THE COUNTY JUDGE



TALKED ABOUT HAVING A COUNTY WIDE CLEAN UP WEEK AND ASKING THE SIX INCORPORATED TOWNS IN THE COUNTY TO EACH ONE SET UP A LARGE DUMPSTER AND A FLAT BED TRAILOR, TO PUT WHITE GOODS ON, AND ENCOURAGE PEOPLE TO CLEAN UP AROUND THEIR PROPERTY. (THE COUNTY WOULD TAKE CARE OF IT.) APRIL OR MAY IS BEING CONSIDERED, WILL HAVE ANOTHER MEETING TO TALK ABOUT IT.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. MEETING ADJOURNED AT 8:45.
