

OAK GROVE TOWN COUNCIL MEETING MINUTES  
DATE: NOVEMBER 5, 1996

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MEETING ON OCTOBER 1, 1996, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED.

ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN SAM JONES AND WILLARD STANDLEE, ALDERWOMEN PAT DAVIS AND VICKIE ALLEN. RECORDER PAT CARLTON AND ALDERMAN GARY HIGH WERE ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF OCTOBER'S MINUTES. THE MINUTES WERE READ. ANY CORRECTIONS OR OMISSIONS? NONE. THE MAYOR ASKED FOR A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT THEM AS READ, ALDERWOMAN PAT DAVIS SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILL FOR THE STOVE AT THE COMMUNITY BUILDING WAS PRESENTED, A BILL TO THE OZARK TRANSIT, A BILL FOR MEDICAL SUPPLIES FOR THE FIRE DEPARTMENT AND THE REGULAR MONTHLY BILLS. A MOTION WAS MADE BY ALDERWOMAN VICKIE ALLEN TO ALLOCATED MONEY TO PAY THE BILLS, ALDERWOMAN PAT DAVIS SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. ALL OPPOSED BY THE SAME. NONE.

A DISCUSSION ABOUT A SMALL BUILDING FOR THE RADIO EQUIPMENT WAS HELD. FIRECHIEF FRAND ALLEN WILL TAKE CARE OF IT. COST OF THE EQUIPMENT WAS DISCUSSED. ALDERMAN SAM JONES MADE A MOTION, IF THE EQUIPMENT COST MORE THAN WAS BUDGETED IN 1995, TAKE IT OUT OF GENERAL FUND AND ADD TO THE FIRE DEPARTMENT FUND. ALDERWOMAN PAT DAVIS SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL I'S. ALL OPPOSED BY THE SAME. NONE.

A TENTATIVE BUDGET WAS PRESENTED TO THE COUNCIL.
