

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: APRIL 1, 1997

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON APRIL 1, 1997, IN THE TOWN HALL FOR A REGULAR MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT. ALDERMEN GARY HIGH, SAM JONES AND EUGENE REYNOLDS, ALDERWOMAN PAT HIGH. RECORDER PAT CARLTON. ALDERWOMAN VICKIE ALLEN WAS ABSENT.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. A BILL FOR TOP SOIL PUT AT THE COMMUNITY GROUNDS\BALL PARK AND FENCE FOR THE SAME WAS PRESENTED ALONG WITH THE REGULAR MONTHLY BILLS. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. ALL OPPOSED BY THE SAME. NONE.

THE COUNCIL SAID TO SEE ABOUT A FIRE-HYDRANT THAT IS FAULTY AND HAVE RODNEY TO SEE IF IT CAN BE FIXED, IF NOT ORDER A NEW ONE. GET KENNETH HIGH TO DO SOME WORK AT THE COMMUNITY BLDG. GET POLES FOR THE FENCE AT THE GROUNDS. GIVE JEFF \$10.00 OFF OF THE BILL HE OWES FOR BALL PARK LIGHTS FOR GAS HE USED TO GET FENCE.

ALDERMAN GARY HIGH MADE A MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. OPPOSED BY THE SAME. NONE.
