

OAK GROVE TOWN COUNCIL MEETING MINUTES

DATE: AUGUST 5, 1997

THE OAK GROVE COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON AUGUST 5, 1997, IN THE TOWN HALL FOR THE REGULAR MONTHLY MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN GARY HIGH AND GENE REYNOLDS, ALDERWOMEN PAT HIGH AND VICKIE ALLEN, RECORDER PAT CARLTON, AND WATER SUPERINTENDANT RODNEY NEWMAN. ALDERMAN SAM JONES WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF MONTH OF JULY MEETING. YOU HAVE HEARD THE READING OF THE MINUTES, ARE THERE ANY OMISSIONS OR CORRECTIONS? ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN GENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. ALL OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. WE RECEIVED FRANCHISE CHECKS FROM THE CABLE CO. AND FROM THE TELEPHONE CO. GARY HIGH, RODNEY NEWMAN, CITY TRACTOR WORK, AND THE REGULAR MONTHLY BILLS WERE PRESENTED. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERWOMAN PAT HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. ALL OPPOSED BY THE SAME. NONE.

THE WATER DEPARTMENT GOT A LETTER TELLING US THAT WE ARE REQUIRED TO HAVE AN AUDIT THIS NEXT YEAR. WILL CHECK ABOUT A QUALIFIED PERSON TO DO IT. DISCUSSION ABOUT THE COMMUNITY BUILDING ROOF. DISCUSSION ABOUT A BETTER WAY TO COLLECT THE LIGHT BILL AT THE BALL PARK FOR NEXT SEASON, WILL DISCUSS LATER. GARY HIGH ASK THE COUNCIL TO THINK ABOUT HIS GETTING PERMISSION TO PUT A 2" LINE TO HIS PROPERTY.

ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ADJOURN. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. ALL OPPOSED BY THE SAME. NONE.
