

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: DECEMBER 2, 1997

THE OAK GROVE COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON DECEMBER 2, 1997, IN THE TOWN HALL FOR A REGULAR MONTHLY MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH. ALDERWOMAN PAT HIGH. ALDERWOMAN VICKIE ALLEN CAME IN LATE. RECORDER PAT CARLTON. FIRE CHIEF FRANK ALLEN WAS PRESENT.

DEVELOPMENT DISTRICT. ALDERMAN GARY HIGH MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN SAM JONES SECONDED. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

FIRST RESPONDERS SCOTT JOUBERT AND TERRY PLUMLEE WERE PRESENT TO PRESENT A LIST OF SUPPLIES THAT ARE NEEDED. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ALLOCATE MONEY FOR NEEDED SUPPLIES. SMALL SUPPLIES PURCHASED, DOESN'T NEED TO BE BROUGHT BEFORE THE COUNCIL FOR PERMISSION TO PURCHASE. \$15.00 TO \$ 20.00. EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE MAYOR GAVE HER REPORT. THE BULBS ARE HERE FOR THE CHRISTMAS DECORATIONS AND CARROLL ELECTRIC CALLED AND SAID THAT THEY WOULD PUT THEM UP WHEN THEY ARE PLACED UNDER THE POLES. THE DOORS ARE HUNG AT THE FIRE DEPARTMENT BUILDING. THE ROOFERS HAVE STARTED ON THE COMMUNITY BUILDING. A LETTER FROM MR. EPLEY CONCERNING THE EMU LAWSUIT WAS PRESENTED.
