

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: JULY 1, 1997

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON JULY 1, 1997, IN THE TOWN HALL FOR THE REGULAR MONTHLY MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT. ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH, ALDERWOMEN PAT HIGH AND VICKIE ALLEN, AND RECORDER PAT CARLTON.

THE MINUTES OF JUNE'S MEETING WERE READ. ANY CORRECTIONS OR OMISSIONS? NONE. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS, BESIDES THE REGULAR MONTHLY BILLS A BILL FOR THE SIGN AT THE COMMUNITY GROUNDS, A BILL TO MUNICIPAL LEAGUE FOR WORKERS COMP., ADDITIONAL TRUCK REPAIRS, PAY RODNEY NEWMAN FOR TWO BELTS HE HAS BROKEN ON HIS MOWER, MOWING THE GROUNDS, WERE PRESENTED. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE THE MONEY TO PAY THE BILLS. ALDERMAN GARY HIGH MADE A MOTION TO SECOND. ALL IN FAVOR SAY I. FIVE I'S. ALL OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE RECOGNITION OF DELEGATION. REX AND JOHN MCCREARY WERE PRESENT TO DISCUSS THE ELECTRIC FENCE THAT BARRY RANDOLPH HAS ERECTED ON HIS PROPERTY NEXT TO A RENT HOUSE THAT HAS SMALL CHILDREN. (THE RENT HOUSE BELONGED TO THEIR FATHER). THEY ALSO QUESTION THE PROPERTY LINE. THEY ARE CONCERNED ABOUT THE SAFETY OF THE CHILDREN. BARRY RANDOLPH HAD HIS PROPERTY SURVED AND THERE IS CONFLICT AS TO EACH PROPERTY. MAYOR MORGAN HAS CALLED AND WAS TOLD THAT THERE IS NO LAW AGAINST HAVING A ELECTRIC FENCE. THEY WERE ADVISED TO TALK TO BARRY OR GET THEIR OWN SURVEY DONE OR GET A LAWYER. IF THE COUNCIL CAN HELP WE WOULD BE GLAD TO DO SO BUT I DON'T KNOW OF ANYTHING WE CAN DO.

DISCUSSION AS TO THE PLACE FOR THE NEW SIGN AT THE COMMUNITY GROUNDS WAS NEXT. MAYOR MORGAN HAS BEEN WORKING ON A GRANT AND GOT CONFORMATION THIS WEEK OF AN OIL OVERCHARGE FUND GRANT TO THE OAK GROVE FIRE DEPARTMENT FOR ENERGY IMPROVEMENTS FOR \$3,000.00. IT HAS TO BE USED FOR ENERGY CONSERVATION FOR THE FIRE BUILDING. A ESTIMATE FROM TIM JONES WAS PRESENTED FOR THE ROOF REPAIR ON THE COMMUNITY BUILDING.

ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. ALL OPPOSED BY THE SAME. NONE.
