

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: MARCH 17, 1997

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A SPECIAL CALLED MEETING MARCH 17, 1997, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT, ALDERMEN GARY HIGH, SAM JONES AND EUGENE REYNOLDS, ALDERWOMEN PAT HIGH AND VICKIE ALLEN. ALDERWOMAN VICKIE ALLEN TOOK THE MINUTES FOR RECORDER PAT CARLTON WHO WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS A DISCUSSION OF INSURANCE FOR THE FIRE TRUCKS. WE HAVE RECEIVED INFORMATION FROM THE MUNICIPAL LEAGUE. IT IS CHEAPER FOR THE SAME COVERAGE. ALDERMAN SAM JONES MADE A MOTION TO CHANGE. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. OPPOSED BY THE SAME. NONE.

THE RABIES CLINIC HAS BEEN SET FOR APRIL 12 AND RAIN DATE THE 19TH.

JEFF JONES WAS PRESENT TO DISCUSS THE BALL PARK AND GAVE AN ESTIMATE FOR SOME FENCE. VANDALISM AND DESTRUCTION OF THE PARK PROPERTY WAS DISCUSSED, HOW TO COLLECT MONEY FOR THE USE OF THE LIGHTS AND WATER USAGE WAS DISCUSSED. ALDERWOMAN PAT HIGH MADE A MOTION THAT MINIMAL REPAIR ON THE FENCE AT THIS TIME UNTIL FURTHER FUNDS CAN BE ALLOCATED. THE BUDGET IS \$500.00 AND IT CAN BE UTILIZED. THE OUT STANDING LIGHT BILL IS TO BE PAID BY BALL LEAGUE BEFORE REPAIRS ARE MADE. EACH COUNCIL MEMBER WILL HAVE A KEY FOR LIGHT USE. THE KEY IS TO BE RETURNED THE SAME NIGHT. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. ALL SAID I. OPPOSED BY THE SAME. NONE.

ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ADJOURN. ALDERWOMAN PAT HIGH SECONDED. ALL IN FAVOR SAY I. ALL SAID I. OPPOSED BY THE SAME. NONE.
