

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: MARCH 4, 1997

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MEETING ON MARCH 4, 1997, IN THE TOWN HALL.
