

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: APRIL 7, 1998

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON APRIL 7, 1998, IN THE TOWN HALL FOR A REGULAR MEETING.
