

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: AUG. 4, 1998

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON AUG. 4, 1998, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN SAM JONES, GARY HIGH AND EUGENE REYNOLDS. ALDERWOMEN PAT HIGH AND VICKIE ALLEN. RECORDER PAT CARLTON.

RECORDER PAT CARLTON TALKED TO THE COUNCIL ABOUT GETTING INS. ON THE COOK SHACK BLD. AND THE BLD. THAT HOUSES THE FIRE DEPT. RADIOS. GO WITH SHELTER INS. AND ASK FOR \$10,000.00 ON THE BLDG. THAT HOUSES THE RADIO EQUIP. AND \$1,000.00 ON THE COOK SHACK. MAYOR JEAN MORGAN READ THE SECOND READING OF ORDINANCE #55-98. WE RECEIVE A CHECK FROM SHELTER INS. AND A FRANCHISE FROM ALLTEL.

THE NEXT ORDER OF BUSINESS WAS THE RECOGNITION OF DELEGATION. JEFF AND KAY JONES WERE PRESENT TO TALK ABOUT THE GRANT THAT CAN BE APPLIED FOR. THE MATCHING GRANT WAS DISCUSSED FOR THE BALL PARK. JEFF PAID \$100.00 ON BALL FIELD LIGHTS, PART WAS FOR LAST YEARS BILL.
