OAK GROVE TOWN COUNCIL MEETING MINUTES DATE: JULY 7,1998

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MEETING ON JULY 7,1998 IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN SAM JONES, GARY HIGH AND EUGENE REYNOLDS. ALDERWOMAN PAT HIGH. RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF THE JUNE MINUTES. YOU HAVE HEARD THE READING OF THE MINUTES, IS THERE ANY CORRECTIONS OR OMISSIONS THAT WE NEED TO ADDRESS? ALDERWOMAN PAT HIGH MADE A MOTION TO ACCEPT AS READ. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED. NONE.

A DISCUSSION ABOUT THE HAIL DAMAGE TO THE BUILDINGS. THE COMMUNITY BUILDING WAS NOT DAMAGED. WE HAVE REPLACED THE ROOF ON THE FIRE DEPARTMENT. ROOFERS WERE TO CHECK THE TWO COOK SHACKS, THE PUMP HOUSE AND THE HOUSE THAT HOUSES THE FIRE DEPARTMENT RADIO EQUIPMENT, BUT HE HAS NOT GOT BACK IN TOUCH WITH THE MAYOR. IF THE COOK SHACK THAT THE SADDLE CLUB BUILT IS DAMAGED, SHOULD THE SADDLE CLUB BE RESPONSIBLE FOR THE ROOF. ALDERMAN EUGENE REYNOLDS SAID HE THOUGHT IF THE SADDLE CLUB BUILT IT, IT SHOULD BE THEIR RESPONSIBILITY. ALL THE COUNCIL WAS IN AGREEMENT.THERE ISN'T ANY INSURANCE ON THE TWO COOK SHACKS NOR THE BUILDING THAT HOUSES THE RADIO EQUIPTMENT.

PROTECTION PLAN, BILL FOR ERWIN AND CO. FOR WATER DEPT.
AUDIT, TWO BILLS FROM EPLEY AND EPLEY AND ALL THE REGULAR
MONTHLY BILLS. THE BILLS WERE GIVEN TO THE COUNCILMEN AND
WERE INITIALED. GARY HIGH MADE A MOTION TO ALLOCATE MONEY TO
