

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: MARCH 3, 1998

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET ON MARCH 3, 1998, IN THE TOWN HALL FOR A REGULAR MONTHLY MEETING. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED.
