

OAK GROVE TOWN COUNCIL MEETING MINUTES  
DATE: OCTOBER 6, 1998

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON OCTOBER 6, 1998, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN EUGENE REYNOLDS AND GARY HIGH, ALDERWOMAN PAT HIGH, RECORDER PAT CARLTON. ALDERWOMAN VICKIE ALLEN WAS LATE. ALDERMAN SAM JONES WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MEETING. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN GARY HIGH SECONDED. ALL IN FAVOR SAY I. THREE I'S. ALL OPPOSED BY THE SAME. NONE. THE READING OF SEPT. SPECIAL MEETING WAS READ. CORRECT THE NO. OF FEET ON GARY HIGHS WATER TO 880 FT. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ACCEPT, WITH THE CORRECTION, AS READ. ALERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. THREE I'S. OPPOSED BY THE SAME. NONE. ( GARY HIGH PAID FOR ALL HIS LINES AND HIS WORK HIMSELF, FROM THE METERS.)

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE MONTHLY BILLS. RICHARD MORGAN GAVE THE CHECK BACK TO THE FIRE DEPARTMENT, THAT HE RECEIVED FOR LABOR, FOR FIXING THE WINDOW. ALDERWOMEN PAT HIGH MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. THREE I'S. ALL OPPOSED BY THE SAME. NONE. THE COUNCIL MEMBERS INITIALED THE BILLS.

RECORDER PAT CARLTON GAVE A REPORT OF HER MEETING WITH THE MO. RURAL WATER ASSOCIATION. ENJOYED THE MEETING AND RECEIVED SOME HELP BUT WAS AT A DISADVANTAGE BECAUSE OF DIFFERENCE BETWEEN AR. AND MO. LAW.

ALDERWOMAN PAT HIGH MADE A MOTION TO ADJOURN. ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

THE ANNOUNCEMENT WAS CALLED INTO THE RADIO STATION OF THE OCTOBER MEETING.
