

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: SEPT. 1, 1998

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MEETING ON SEPT. 1, 1998 IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER, AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN SAM JONES, GARY HIGH AND EUGENE REYNOLDS. ALDERWOMEN VICKIE ALLEN AND PAT HIGH. RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF AUG. MINUTES. ANY CORRECTIONS OR OMISSIONS? ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERWOMAN VICKIE ALLEN SECONDED. ALL IN FAVOR SAY I. FIVE I'S, OPPOSED BY THE SAME. NONE.

WE RECEIVED A CHECK FROM THE CABLE CO.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. BESIDE THE REGULAR MONTHLY BILLS, A BILL FOR INSURANCE ON THE COMMUNITY BLDG., KENNETH HIGH, CARROLL COUNTY NEWSPAPERS, AND A RE-IMBURSE TO EUGENE REYNOLDS. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERWOMAN VICKIE ALLEN SECONDED. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE. THE BILLS WERE INITIALED.

THE MAYOR TALKED ABOUT DOING AWAY WITH THE PERSONAL PROPERTY TAXES THAT WILL BE ON THE NOV. BALLOT. SHE ENCOURAGED THE COUNCIL TO READ THE ARTICLES THAT HAVE COME OUT IN THE CITY AND TOWN MAGAZINE. THE MAYOR READ ORDINANCE #55-98 BY TITLE ONLY. ALL IN FAVOR OF ADOPTING ORDINANCE #55-98 SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

RE-CORDER PAT CARLTON TOLD THE COUNCIL ABOUT A MEETING FOR RE-CORDERS IN CASSVILLE, MO. SEPT. 25TH. WAS TOLD IT WAS A GOOD IDEA AND THE WATER DEPT. COULD PAY THE 20.00 FEE.

THE FIRE DEPARTMENT WILL HAVE TWO TRUCKS IN THE BLUE EYE REUNION. THEY HAVE PERMISSION TO BUY CANDY TO THROW TO THE CROWD.
