

OAK GROVE TOWN COUNCIL MEETING MINUTES

DATE: APRIL 6, 1999

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON APRIL 6, 1999, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: 1 ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH. ALDERWOMEN PAT HIGH AND VICKIE ALLEN & RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MO. MINUTES. ONE CORRECTION: VICKIE ALLEN WAS LATE INSTEAD OF ABSENT. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT AS READ WITH THE CORRECTION, ALDERMAN GARY HIGH SECONDED. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. ALL BILLS WERE REGULAR MONTHLY BILLS WITH THE EXCEPTION OF ONE FROM CCN NEWSPAPERS. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

MAYOR MORGAN GAVE HER REPORT. SHE WILL CONTACT THE CO. JUDGE ABOUT THE COST TO USE HOT MIX INSTEAD OF DOUBLE CHIP & SEAL ON CR 614 & CR 433. THE VACCINATION CLICIC IS SET FOR APRIL 24, RAIN DATE, MAY 1. DISCUSSION ABOUT THE TWO FIRE TRUCKS THAT THE FIRE DEPT. BID ON FROM SPRINGDALE AND WAS THE LOW BIDDERS. TALKED ABOUT PAYING FOR THEM. CAN USE 833 MONEY. FIRE DEPT. MONEY AND MONEY FROM GENERAL FUND. THE FIRE DEPT. WILL HOST A BARBEQUE SAT. APRIL 3, AT THE COMMUNITY BUILDING.
