

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE : AUG. 13,1999

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE MET FOR A SPECIAL CALLED MEETING ON AUG. 13,1999, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT- ALDERMEN EUGENE REYNOLDS AND SAM JONES. ALDERWOMAN PAT HIGH.
