

OAK GROVE TOWN COUNCIL MEETING MINUTES

DATE: MAR. 2, 1999

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON MAR. 2, 1999, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN EUGENE REYNOLDS AND GARY HIGH, ALDERWOMAN PAT HIGH, ALDERMAN SAM JONES ~~also~~, ALDERWOMAN VICKIE ALLEN ~~was absent~~, RECORDER PAT CARLTON AND WATER SUPERINTENDENT RODNEY NEWMAN. CCN STAFF WRITER ANNA MATHEWS WAS ALSO PRESENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF FEB. MEETING MINUTES. ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME, NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. BESIDE THE REGULAR MONTHLY BILLS WERE BILLS FROM SHIBLEY INS. FOR WATER DEPT., AR. MUNICIPAL LEAGUE FOR HANDBOOK, EMERGENCY SERVICE PRODUCTS AND CARROLL CO. NEWSPAPERS. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS, ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I, FOUR I'S. OPPOSED BY THE SAME. NONE.

MAYOR MORGAN GAVE HER REPORT. THE DELEGATION THAT TRAVELED TO L.A. TO CHECK ON A FIRE TRUCK, FOUND THE TRUCK TOO OLD AND WORN OUT. WE HAVE A BID FOR AN AUDIT FOR THE WATER DEPT. THE COUNCIL THINKS IT IS HIGH. PAT WILL GET OTHER QUOTES. THE BALL PARK AND GROUNDS NEEDS REPAIRS. AFTER DISCUSSION, GARY HIGH IS TO CHECK ON FIXING FENCE AND BASKETBALL GOALS.

PAT CARLTON PRESENTED BIDS ON A NEW COMPUTER AND PRINTER. JANETTE REYNOLDS CAME TO SESSION AND HELPED ELIMATE SOME AND AGREED TO ACCOMPANY PAT TO BYTE SIZE COMPUTERS AND SEE IF WE COULD MAKE A BETTER DEAL WITH LESS PROGRAMS THAT COME WITH THE PACKAGE THAT WE DON'T NEED. ALDERMAN GARY HIGH MADE A MOTION TO LET PAT USE HER OWN DESCRIPTION AS TO THE BUY. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

RODNEY NEWMAN WAS PRESENT TO TALK OF A WATER CONFERENCE THAT HE WOULD LIKE TO ATTEND. IT WILL ALSO COUNT TOWARD HIS REQUIRED HOURS. EUGENE REYNOLDS MADE A MOTION TO SEND AND TO PAY EXPENSES AND LOST PAY. ALDERWOMAN PAT HIGH SECONDED. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

ALDERMAN GARY HIGH MADE A MOTION TO ADJOURN. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.
