

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE; MAY 4,1999

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON MAY 4,1999, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN, PRESIDING OFFICER AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN SAM JONES, GARY HIGH AND EUGENE REYNOLDS. MAYOR MORGAN GAVE HER REPORT. SHE HAS TALKED TO THE COUNTY JUDGE ABOUT DOUBLE CHIP AND SEAL FOR SOME OF THE ROADS. THE FIRE DEPARTMENTS FUND RAISER FOR THE FIRST RESPONDERS WAS A GOOD SUCCESS. PAT CALL THE PHONE CO. TO FIND OUT ABOUT GETTING THE FAX MACHINE ON THE COMPUTER SET UP.
