

OAK GROVE TOWN COUNCIL MEETING MINUTES

DATE: OCTOBER 5, 1999

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON OCTOBER 5, 1999, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT: ALDERMEN SAM JONES, EUGENE REYNOLDS AND GARY HIGH. ALDERWOMAN PAT HIGH, RECORDER PAT CARLTON AND WATER SUPERINTENDENT RODNEY NEWMAN. ALDERWOMAN VICKIE ALLEN WAS LATE.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES THE MINUTES WERE READ. ANY CORRECTIONS OR OMISSIONS? ALDERMAN GARY HUGH MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE PRESENTED, THE COUNCIL CHECKED AND INITIALED THEM. BESIDE THE REGULAR MONTHLY BILLS WERE BILLS TO AR. MUNICIPAL LEAGUE, HUGHES SUPPLY, CARROLL COUNTY NEWSPAPERS AND A REIMBURSE TO EUGENE REYNOLDS FOR PICKING UP THE TABLES AND CHAIRS AT SAMS FOR THE COMMUNITY BLDG. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

SECRETARY PAT CARLTON CHECKED FOUR INSURANCE COMPANIES ABOUT INSURANCE FOR THE COMMUNITY BLDG. ALL WERE HIGHER OR WOULD NOT INSURE BECAUSE OF THE WOOD HEAT. STAYED WITH FARMERS MUTUAL.

MAYORS REPORT: GOT THE TABLES AND CHAIRS FOR THE COMMUNITY BLDG. GARY HIGH DROP THE REST OF THE OLD CANNING FACTORY IF MR. TANKSLY IS THROUGH. PUT \$500.00 IN THE FIRE DEPARTMENTS FUND.

ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ADJOURN, ALDERWOMAN VICKIE ALLEN SECONDED. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.
