

OAK GROVE TOWN COUNCIL MEETING MINUTES

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR THE REGULAR MONTHLY MEETING ON MARCH 4, 2000, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. THE FOLLOWING ANSWERED ROLL CALL; ALDERMEN EUGENE REYNOLDS, SAM JONES AND GARY HIGH. ALDERWOMEN VICKIE ALLEN AND PAT HIGH, RECORDER PAT CARLTON.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MEETING. ANY CORRECTIONS, OMISSIONS OR DISCUSSIONS? ALDERMAN GARY HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. HAD A BILL FROM AR. RURAL WATER ASSOCIATION AND FROM BRADLEY BOYS, BESIDE THE REGULAR MONTHLY BILLS. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S, OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE RECOGNITION OF DELEGATION. DAVID FOSTER WAS PRESENT TO ASK ABOUT GETTING WATER TO HIS PROPERTY. AFTER DISCUSSION IT WAS DECIDED IT WOULD BE VERY EXPENSIVE. WILLARD STANDLEE HAS ASKED ABOUT GETTING WATER TO A HOUSING DEVELOPING HE IS PLANNING TO BUILD. HE WAS TOLD TO COME TO THE COUNCIL MEETING TO DISCUSS THE MATTER.

MAYOR MORGAN GAVE HER REPORT, SHE GAVE EACH COUNCIL MEMBER A REPORT OUTLINING THE COST AND PAYMENTS OF THE FERGUSON BLDH., IF THE FIRE DEPARTMENT CAN PURCHASE IT. ALDERMAN SAM JONES MADE A MOTION TO ACCEPT THE OFFER TO BUY THE BUILDING. ALDERMAN EUGENE REYNOLDS SECONDED. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ADJOURN. ALDERWOMAN PAT HIGH SECONDED. ALL IN FAVOR SAY I, FIVE I'S. OPPOSED BY THE SAME. NONE.
