

OAK GROVE TOWN COUNCIL MEETING MINUTES
DATE: MAY 2, 2000

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING ON MAY 2, 2000, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERWOMEN VICKIE ALLEN AND PAT HIGH, ALDERMEN SAM JONES, GARY HIGH AND EUGENE REYNOLDS. RECORDER PAT CARLTON. ANNA MATTHEWS FROM CARROLL CO. NEWSPAPERS WAS PRESENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF LAST MONTHS MINUTES. THE REGULAR MINUTES WERE READ. ANY CORRECTIONS OR OMISSIONS? ALDERWOMAN PAT HIGH MADE A MOTION TO ACCEPT THE MINUTES AS READ. ALDERMAN EUGENE REYNOLDS SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE. THE SPECIAL CALLED MEETING MINUTES WERE READ. ANY CORRECTIONS OR OMISSIONS? ALDERMAN SAM JONES MADE A MOTION TO ACCEPT AS READ. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.

THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE CHECKED AND INITIALED BY THE COUNCIL. ALDERMAN SAM JONES MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN GARY HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE

THE MAYOR GAVE HER REPORT. SHE GAVE EACH COUNCIL MEMBER A COPY OF AN ORDINANCE FOR REGULATING UNSANITARY AND UNSIGHTLY CONDITIONS AND A COPY OF A ORDINANCE TO ESTABLISH POLICIES FOR THE WATER DEPT. THAT MR. EPLEY HAS SENT FOR THE COUNCIL TO LOOK OVER. AFTER MUCH DISCUSSION ON EACH ORDINANCE ,SOME CHANGES WERE MADE AND SOME NEW ONES DISCUSSED. IT WAS DECIEDED THAT WE NEED TO FIND OUT SOME MORE INFORMATION AND STUDY THE ORDINANCE S BEFORE PASSING.

ALDERWOMAN VICKIE ALLEN MADE A MOTION TO ADJOURN. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FIVE I'S. OPPOSED BY THE SAME. NONE.
