

OAK GROVE TOWN COUNCIL MEETING MINUTES  
DATE; NOVEMBER 7,2000

THE OAK GROVE TOWN COUNCIL OF THE TOWN OF OAK GROVE, AR., MET FOR A REGULAR MONTHLY MEETING NOVEMBER 7,2000, IN THE TOWN HALL. THE MEETING WAS CALLED TO ORDER BY MAYOR JEAN MORGAN AND A QUORUM WAS ESTABLISHED. ON ROLL CALL THE FOLLOWING WERE PRESENT; ALDERMEN EUGENE REYNOLDS AND SAM JONES. ALDERWOMEN PAT HIGH AND VICKIE ALLEN AND RECORDER PAT CARLTON, ALDERMAN GARY HIGH WAS ABSENT.

THE FIRST ORDER OF BUSINESS WAS THE READING OF THE OCTOBER MINUTES. ALDERMAN EUGENE REYNOLDS MADE A MOTION TO ACCEPT THE MINUTES AS READ, ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVORE SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.


THE NEXT ORDER OF BUSINESS WAS THE PRESENTATION OF THE BILLS. THE BILLS WERE PRESENTED TO THE COUNCILMEMBERS AND WERE CHECKED AND INITIALED. BILLS BESIDE THE REGULAR MONTHLY BILLS WERE BILLS FOR INSURANCE FOR THE FIRE STATION #1, FANS AND HARDWARE FOR THE COMMUNITY BLDG., AWNING AND HARDWARE, MUNICIPALLEAGUE LEGAL DEFENSE AND LIFE INSURANCE. ALDERWOMAN PAT HIGH MADE A MOTION TO ALLOCATE MONEY TO PAY THE BILLS. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

NEW BUSINESS; DISCUSSION ON INSURANCE ON FIRE STATION # 2, PAT CARLTON HAD CHECKED WITH THE SAME COMPANY WE HAVE FOR #1 STATION AND FOR INSURANCE ON THE FENCE AT THE COMMUNITY BLDG./BALL FIELD. ALDERWOMAN VICKIE ALLEN MADE A MOTION TO GO WITH SHELTER INS. ALDERMAN SAM JONES SECONDED THE MOTION. ALL IF FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.

PAT CARLTON PRESENTED THE PROPOSED TOWN BUDGET FOR 2001 AND THE WATER DEPARTMENTS BUDGET. ALDERWOMAN PAT HIGH MADE A MOTION TO ACCEPT THE WATER DEPARTMENTS BUDGET FOR 2001(INCOME \$48,800.00, EXPENSES \$62,416.00, NON-OPERATING INCOME \$1,200.00. CASH FLOW BEGINNING BALANCES \$96,000.00 AND ENDING BALANCES \$97,816.00), ALDERWOMAN VICKIE ALLEN SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. A CHECK FOR LOPFI WAS RECEIVED.

ALDERMAN SAM JONES MADE A MOTION TO ADJOURN, ALDERWOMAN PAT HIGH SECONDED THE MOTION. ALL IN FAVOR SAY I. FOUR I'S. OPPOSED BY THE SAME. NONE.
